1 Definitions

1.1 The following words shall bear the meanings set opposite to them unless inconsistent with the subject or context:

“**Accounting Period**” means, unless otherwise determined by the Directors, a financial period of the ICAV commencing in the case of the first such period on the date of registration with the Central Bank and terminating on 31 December 2021 or such other date as the Directors may from time to time determine and in any other case commencing on the end of the last financial period and ending on 31 December of each year or such other date as the Directors may determine from time to time.

“**Act**” means the Irish Collective Asset-management Vehicles Act 2015 - 2020 and every modification or re-enactment thereof for the time being in force.

“**Administrator**” means any person, firm or corporation appointed by the ICAV and / or the AIFM from time to time and for the time being responsible for the provision of administration, fund accounting and related services to the ICAV.

“**AIF**” means an alternative investment fund as defined in the AIFM Regulations.

“**AIF Rulebook**” means the rulebook issued by the Central Bank as amended from time to time which sets out the Central Bank’s regulatory regime for AIFs and other relevant entities that fall to be regulated under the AIFMD and any regulations issued in replacement of the rulebook.

“**AIFM**” means the person, firm or corporation appointed and from time to time acting as the alternative investment fund manager of the ICAV (if any) pursuant to the AIFM Regulations, which may be the ICAV itself, the Investment Manager or another service provider to the ICAV.

“**AIFMD**” means the Alternative Investment Fund Managers Directive (Directive 2011/61/EU) (as amended).

“**AIFM Regulations**” means the European Union (Alternative Investment Fund Managers) Regulations 2013 (S.I. 257 of 2013) as amended from time to time, and all applicable Central Bank regulations made, conditions imposed or derogations granted thereunder.

“**AIFM Rules**” means any rules or conditions from time to time made by the Central Bank pursuant to the Act and the AIFM Regulations, and, including without limitation, the AIF Rulebook.

“**Annual Report**” means a report prepared in accordance with Section 37 hereof.

“**Auditors**” means the auditors for the time being of the ICAV.

“**Authorised AIFM**” means an AIFM that is authorised pursuant to the AIFMD, as implemented in the AIFM’s home member or member state of reference, as applicable.

“**Base Currency**” means, in respect of a Fund, the currency of account of such Fund as determined by the Directors and disclosed in the Prospectus.

“Beneficial Ownership Regulations” means the European Union (Anti-Money Laundering Beneficial Ownership of Corporate Entities) Regulations 2019 as may be amended, consolidated or substituted from time to time.

“Benefit Plan Investor” means an employee benefit plan, as described in Section 3(3) of ERISA that is subject to Title I of ERISA, a plan subject to Section 4975 of the United States Internal Revenue Code 1986, as amended, or a governmental plan or church plan which is subject to any federal, state or local law that is substantially similar to the provisions of Section 406 of ERISA or Section 4975 of the Code, or an entity whose assets are treated as assets of such a plan or such other entity as the Directors may determine and disclose in the Prospectus.

“Business Day” means such day or days as the Directors from time to time may determine in relation to a Fund and specify in the Prospectus.

“Capital Commitment” means, with respect to a Capital Commitment Fund, the amount of capital which an investor shall agree to subscribe to a Fund for the purchase of Shares by such investor.

“Capital Commitment Fund” means a Fund which operates a capital commitment mechanism, as detailed in the Prospectus.

“Capital Contribution” means, in respect of a Fund which is either closed-ended or of limited liquidity, if so determined by the Directors and reflected in the Prospectus or relevant Supplement, the payment for Shares pursuant to a Drawdown Notice.

“Capital Contribution Day” means, in respect of a closed-ended or limited liquidity Fund as determined by the Directors, a Business Day, specified in an Investor’s or Shareholder’s capital commitment agreement or pursuant to a Drawdown Notice, on which a Capital Contribution is required to be made or is made to purchase and pay for Shares of a Class in respect of all or part of such Investor’s or Shareholder’s Capital Commitment.

“Central Bank” means the Central Bank of Ireland or any successor thereto.

“Class” means a separate class or separate classes of Shares established by the ICAV in any particular Fund in order to accommodate different arrangements in relation thereto.

“Class Currency” means the currency in which a Class of a Fund is designated, as determined by the Directors and disclosed in the Prospectus.

“Class Level Transactions” means any transaction or allocation permitted by the Central Bank from time to time (including foreign exchange hedging, interest rate hedging, investment in New Issues or other assets and the use of financial derivative instruments) and applied with respect to any given Class such that the benefits and costs of such transaction or allocation are accrued and attributed solely to the relevant Class.

“Commitment Period” means, in relation to each Capital Commitment Fund and investor therein, the period during which Capital Commitments may be drawn down as may be specified in the Prospectus. Where no such period is specified in the Prospectus, the Commitment Period shall be any time during the period in which the Fund is in existence.

“Dealing Day” means such day or days as the Directors from time to time may determine in relation to a Fund and specify in the Prospectus.

“Depository” means any person, firm or corporation appointed and for the time being responsible for the safekeeping of all of the assets of the ICAV.

“Depository Agreement” means the agreement pursuant to which the Depository was appointed as depository to the ICAV.

“Director” means any director of the ICAV for the time being.

“Distributor” means any person, firm or corporation appointed by the ICAV or the AIFM (or its delegates) from time to time and for the time being responsible for the provision of distribution and related services to the ICAV.

“Drawdown Notice” means, in relation to each Capital Commitment Fund, the written request from a Fund to a Shareholder for payment of a proportion of its Capital Commitment.

“Euronext Dublin” means The Irish Stock Exchange plc (trading as Euronext Dublin).

“Exempt Investor” means the Irish Residents specified as exempt investors in the Prospectus.

“External Valuer” means a person, independent from the ICAV, the AIFM and any other person with close links to the ICAV or the AIFM, appointed by the AIFM to value the assets of the ICAV.

“ERISA” means the United States Employee Retirement Income Security Act of 1974, as amended.

“Final Closing Date” means, in respect of a Fund which is either closed-ended or of limited liquidity, if so determined by the Directors, the final date, as set out in the Prospectus or relevant Supplement, on which subscriptions from applicants may be accepted by the ICAV in respect of that Fund or a Class thereof.

“Fractional Share” means a fractional share in the ICAV issued in accordance with Section 12.6.

“Fund” means any sub-fund from time to time established pursuant to Section 9 and which may comprise one or more Classes of Shares in the ICAV.

“ICAV” means an Irish collective asset-management vehicle registered pursuant to the Act. References to **“the ICAV”** shall be to the ICAV to which this Instrument relates.

“Indemnified Person” means the Directors, the AIFM, any member of the Investor Advisory Committee and, in each case, their respective affiliates and any of the respective officers, directors, delegates, members, employees, secondees, agents, advisors, affiliates or the legal representatives of any of them.

“Initial Closing Date” means, in respect of a Fund which is either closed-ended or of limited liquidity, the date as determined by the Directors, Shares are first issued during the Initial Offer Period of that Fund or a Class thereof.

“Initial Offer Period” means the period determined by the Directors during which Shares of any Class are offered by the ICAV for purchase or subscription at the Initial Price.

“Initial Price” means the price at which any Shares of any Class are first offered for purchase or subscription.

“Instrument” means this instrument of incorporation, including the Schedules, as amended from time to time.

“Intermediary Vehicle” means any subsidiary or other company, entity or arrangement (such as a limited partnership, unit trust or trust) in which the ICAV, or a Fund, holds any direct or indirect interest (whether characterised as equity, debt or otherwise, including a co-investment or fractional interest) for the purpose of structuring the holding of one or more Investments.

“Investment” means any of the investments of the ICAV as more particularly set out in the Prospectus, including, in particular, any investments held through a Subsidiary.

“Investment Period” means a period during which a Capital Commitment Fund may make investments, as set out in the Prospectus or the relevant Supplement.

“Investor” means any person who is or becomes an investor in any Fund by assuming a Commitment or by purchasing or subscribing for Shares and, where the context requires, will include that person as a Shareholder.

“Investor Advisory Committee” means any committee formed by the ICAV or the AIFM in respect of one or more Funds for the purposes and with the duties, obligations and authorities as may be determined by the ICAV and set out in the Prospectus and/or the relevant Supplement.

“Irish Resident” means any company resident or other person resident or ordinarily resident, in the Republic of Ireland for the purposes of Irish tax.

“Investment Manager” means any person, firm or corporation appointed by the ICAV and / or the AIFM from time to time in accordance with the requirements of the Central Bank and for the time being providing investment management and / or investment advisory services to the ICAV.

“in writing” means written, printed, lithographed, photographed, telexed, telefaxed or represented by any other substitute for writing, whether electronic or otherwise, or partly one and partly another.

“Knowledgeable Investor” means such investors, as specified in the Prospectus from time to time, who are permitted to acquire Shares in accordance with the requirements of the Central Bank including:

- (a) the AIFM, Investment Manager or any other entity appointed to provide investment management or advisory services to the ICAV;
- (b) a director of the AIFM, Investment Manager, ICAV or a director of any other entity appointed to provide investment management or advisory services to the ICAV;

- (c) an employee of the AIFM, Investment Manager, or an employee of any other entity appointed to provide investment management or advisory services to the ICAV, where the employee is:
- (i) directly involved in the investment activities of the ICAV; or
 - (ii) a senior employee of the company and has experience in the provision of investment management services;

and, in the case of an employee, whom the ICAV is satisfied falls within the criteria outlined at (i) and (ii) and who certifies in writing to the ICAV that he/she is:

- (i) making use of the exemption from the minimum subscription requirement of €100,000 (or such other amount as may be specified by the Central Bank) on the basis that he / she is a “*Knowledgeable Investor*”;
- (ii) aware that the ICAV is usually marketed to Qualifying Investors who are normally subject to a minimum subscription requirement of €100,000 (or such other amount as may be specified by the Central Bank);
- (iii) aware of the risk involved in the proposed investment; and
- (iv) aware that inherent in such investment, is the potential to lose all of the sum invested.

“**Minimum Holding**” means the minimum holding (if any) from time to time specified in the Prospectus.

“**Minimum Subscription**” means the minimum subscription from time to time specified in the Prospectus.

“**month**” means calendar month.

“**New Issue**” has the meaning set out pursuant to Financial Industry Regulatory Authority Rule 5130 to include any initial public offering of an equity security as defined in Section 3(a)(11) of the U.S. Securities Exchange Act of 1934 (as amended) made pursuant to a registration statement or offering circular.

“**Net Asset Value**” means the amount determined for any particular Dealing Day pursuant to Section 21 and Schedule 2 hereof.

“**Officer**” means any Director or the Secretary.

“**Ordinary Resolution**” means a unanimous written resolution of the ICAV or of any Fund or Class of Shares in the ICAV, as appropriate, or a resolution passed by a simple majority of the of the votes cast by the members of the ICAV or of any Fund or Class of Shares in the ICAV, as appropriate, in person or by proxy at a general meeting of the ICAV or any Fund or Class of Shares in the ICAV, as appropriate.

“Performance Fee” means a performance fee in such amount as shall be agreed between the AIFM and / or the ICAV and the Investment Manager which shall be disclosed in the Prospectus.

“Permitted US Person” means a US Person, or category of US Person, that the Directors have determined to permit to purchase Shares in a Fund.

“Preliminary Expenses” means the preliminary expenses incurred in connection with the incorporation of the ICAV, the obtaining by the ICAV of authorisation and designation from the Central Bank under the Act and the initial offer of Shares pursuant to the Prospectus including the costs and expenses of preparing, publishing and distributing the Prospectus and all professional and legal fees and costs incurred in connection therewith.

“Prospectus” means the prospectus from time to time issued by the ICAV in relation to the ICAV and any supplement or supplements in relation to any Fund or Funds and any addendum designed to be read and construed together with and to form part of the prospectus.

“Qualifying Investor” means:

- (a) An investor who is a professional client within the meaning of Annex II of Directive 2014/65/EC (Markets in Financial Instruments); or
- (b) An investor who receives an appraisal from an EU credit institution, a MiFID firm or a UCITS management company that the investor has the appropriate expertise, experience and knowledge to adequately understand an investment in the ICAV; or
- (c) An investor who certifies that they are an informed investor by providing the following:
 - (i) a written confirmation to the ICAV that the investor has such knowledge of and experience in financial and business matters as would enable the investor to properly evaluate the merits and risks of the prospective investment in the ICAV; or
 - (ii) a written confirmation to the ICAV that the investor’s business involves, whether for its own account or the account of others, the management, acquisition or disposal of property of the same kind as the property of the ICAV; or
- (d) Such other person or persons as may be permitted to acquire Shares in accordance with the AIFM Regulations.

AND

For categories (a) to (d) above, certified in writing to the ICAV that:

- (i) they are aware of the risk involved in the proposed investment; and
- (ii) they are aware that inherent in such investment is the potential to lose all of the sum invested.

“Recognised Market” means any stock exchange, over-the-counter market or other securities market in any part of the world.

“Register” means the register in which are listed the names of Shareholders.

“Secretary” means any person, firm or corporation appointed by the ICAV to perform any of the duties of the secretary of the ICAV.

“Series” means in relation to each Class of Shares in a Fund, a series of that Class, provided that if a Class of Shares has not been issued in multiple series, the term series shall mean all Shares of the relevant Class where the context so requires.

“Share” or **“Shares”** means a share or shares in the ICAV representing interests in a Fund. Shares may be divided into different Classes, and each Class may be divided into different Series.

“Shareholder” or **“Shareholders”** means a person or persons registered as a holder of Shares.

“signed” includes a signature or representation of a signature affixed by mechanical or other means.

“Special Resolution” means a unanimous written resolution of the ICAV or of any Fund or Class of Shares in the ICAV, as appropriate, or a resolution passed by not less than 75% of the of the votes cast by the members of the ICAV or any Fund or Class of Shares in the ICAV, as appropriate, in person or by proxy at a general meeting of the ICAV or any Fund or Class of Shares in the ICAV, as appropriate.

“Status Declarations” has the meaning given to it in Section 12.2.

“Subscriber Shares” means the Shares which the subscribers to the Instrument of the ICAV agree to subscribe for as more particularly hereinafter set forth after their names.

“Subscription Agreement” means the subscription agreement, account opening form or other document executed by a prospective investor in order to become a Shareholder, and any ancillary or other documents related thereto.

“Subsequent Closing” means, in respect of a Fund which is either closed-ended or of limited liquidity, if so determined by the Directors, the date on which a Fund may accept additional subscriptions from new Investors and/or existing Shareholders following the Initial Closing Date as may be set out in the Prospectus or the relevant Supplement.

“Subsidiary” means any subsidiary which is wholly owned by a Fund and used by it to hold assets, including those within the meaning of section 7 of the Companies Act 2014.

“TCA 1997” means the Taxes Consolidation Act 1997 (as amended or supplemented from time to time).

“Term” means the date on which a closed-ended or limited liquidity Fund terminates if determined by the Directors and specified in the Prospectus or the relevant Supplement.

“US Person” means, unless otherwise indicated in the Prospectus, a person that (i) is a “U.S. person” as defined in Regulation S under the U.S. Securities Act of 1933, as amended, or (ii) is not a “Non-United States person” as defined in Rule 4.7 under the U.S. Commodity Exchange Act.

“Valuation Period” means a period:

- (a) commencing on:
 - (i) in the case of the initial Valuation Period, the date of commencement of operations of the relevant Fund; or
 - (ii) in the case of each subsequent Valuation Period, immediately following the close of the previous Valuation Point; and
- (b) terminating on the first to occur of:
 - (i) the last calendar day of each Accounting Period;
 - (ii) the next Valuation Point; or
 - (iii) the date when the relevant Fund shall dissolve.

“Valuation Point” means such time as the Directors shall determine and specify in the Prospectus, being the time as of which the value of assets and liabilities of a Fund shall be calculated and which shall be at least as often as the relevant Fund deals. In the case of closed-ended Funds or open-ended Funds with limited liquidity, there shall be at least one Valuation Point each calendar year.

“Valuer” means such entity as may for the time be used by the AIFM to provide valuation services in relation to the assets of the ICAV.

1.2 Reference to enactments and to articles and sections of enactments shall include reference to any modifications or re-enactments thereof for the time being in force.

1.3 Unless repugnant to the context:

- 1.3.1 words importing the singular number shall include the plural number and vice versa;
- 1.3.2 words importing the masculine gender only shall include the feminine gender;
- 1.3.3 words importing persons only shall include companies or associations or bodies of persons, whether corporate or not;
- 1.3.4 the word “*may*” shall be construed as permissive and the word “*shall*” shall be construed as imperative.

1.4 Nothing in this Instrument shall be construed so as to prohibit the ICAV, the AIFM, the Investment Manager, the Depositary, the Administrator or any other service provider to the ICAV from complying with any applicable law, rule and / or regulation including but not limited to the AIFMD and any applicable AIFM Rules. Furthermore, the terms of the appointment of any AIFM, Investment Manager, Depositary, the Administrator and other service provider

shall be in accordance with applicable law, rule and / or regulation including but not limited to the AIFMD and any applicable AIFM Rules.

2 Name of the ICAV

2.1 The name of the ICAV is AXA Global Infrastructure Equity ICAV.

2.2 No change in the name of the ICAV shall be made without the prior approval of the Central Bank and any such change shall be in accordance with the Act and the requirements of the Central Bank.

3 Constitution and Type of Vehicle

3.1 The ICAV is a variable capital investment corporate body established pursuant to the Act and is constituted as an umbrella fund with segregated liability between Funds.

3.2 The ICAV is, for the purposes of the AIFM Rules, categorised as an AIF.

3.3 The registered office of the ICAV shall be situated in Ireland.

4 Object

4.1 The sole object of the ICAV shall be the collective investment of the funds in property and giving members the benefit of the results of the management of its funds. The ICAV shall invest the funds available to it, or the part thereof attributable to a Fund, in property as permitted by the Central Bank in accordance with the AIFM Regulations and the AIFM Rules for the purpose of giving to Shareholders the benefit of the results of the management of its funds, as further described in the Prospectus. The ICAV may take any measure and carry out any operations which it may deem useful or necessary to the accomplishment and development of its purpose to the full extent permitted by applicable law.

4.2 For the purposes of achieving its object, the ICAV shall also have the powers set out in Schedule 3.

4.3 Each of the powers of the ICAV (whether enumerated or not) is to be interpreted and exercised as ancillary to the main object but separate from and ranking equally to any other power.

4.4 Subject to the provisions of the Act, the business of the ICAV shall be commenced as soon after the registration of the ICAV as the Directors think fit.

4.5 The ICAV may pursue its investment objectives by utilising an intermediate investment vehicle, such as a trust, ICAV or company, and by advancing monies for investment by such vehicle by way of loan, subscription for equity capital or otherwise, provided that where the ICAV uses an ICAV or company as an intermediate vehicle, the ICAV shall maintain beneficial ownership of all of the issued share capital of such ICAV or company and the Shares in such ICAV or company and the assets of such ICAV or company shall be kept under the control of the Depositary or its sub-custodians.

5 **Base Currency**

The accounts of the ICAV or each Fund shall be prepared in the Base Currency. The currency of denomination of each Fund shall be that as stated in the Prospectus.

6 **Expenses**

6.1 The charges and expenses of the ICAV may be discharged out of the assets of the ICAV.

6.2 The Preliminary Expenses shall be payable by the ICAV and the amount so payable may in the accounts of the ICAV be carried forward and amortised in such manner and over such period as the Directors may determine and the Directors may at any time and from time to time determine to lengthen or shorten any such period. The ICAV shall reimburse the AIFM and / or the Investment Manager or its affiliates for any and all Preliminary Expenses initially paid by the AIFM and / or Investment Manager on behalf of the ICAV.

6.3 The ICAV may also bear the following expenses:

6.3.1 all taxes and expenses which may be incurred in connection with the acquisition and disposal of Investments and all other assets of the ICAV;

6.3.2 all taxes which may be payable on the assets, income and expenses chargeable to the ICAV;

6.3.3 all brokerage, bank and other charges incurred by the ICAV in relation to its business transactions;

6.3.4 all remuneration, fees, costs and expenses due to the AIFM, the Depositary, the Investment Manager, the Administrator, the Distributors, the Auditors and the legal advisers to the ICAV and any other person, firm or corporation providing services to or for the benefit of the ICAV;

6.3.5 all expenses incurred in connection with publication and supply of information to Shareholders and in particular, but without limitation, the cost of printing and distributing the annual audited financial statements as well as any other reports to the Central Bank or to any other regulatory authority or the Shareholders and the cost of preparing, publishing and distributing the Prospectus and any subsequent offering documents for Shares (including the costs of developing and enhancing computer software and electronic transmission techniques to distribute such documents or information) and the cost of all stationery, printing and postage costs in connection with the preparation and distribution of information to Shareholders, the expense of publishing daily price and yield information in relevant media and all marketing and promotional expenses;

6.3.6 all expenses incurred in registering the ICAV with any governmental agencies or regulatory authorities and maintaining the registration of the ICAV with such governmental agencies or regulatory authorities, (including local securities dealers associations) and the cost of listing and maintaining a listing of Shares on any stock exchange;

6.3.7 all expenses incurred in connection with the operation and management of the ICAV, including, without limitation to the generality of the foregoing, all Directors'

fees, all costs incurred in organising Directors' meetings and Shareholders' meetings and obtaining proxies in relation to such meetings, all insurance premiums and association membership dues and all non-recurring and extraordinary items of expenditure as may arise;

- 6.3.8 all sums payable in respect of any policy of insurance taken out by the ICAV including, without limitation, any policy in respect of directors' and officers' liability insurance cover and liability cover for the relevant Investor Advisory Committee;
 - 6.3.9 any fees or expenses incurred by a Fund established exclusively for the purpose of investing substantially all of its assets in the ICAV or any Fund of the ICAV;
 - 6.3.10 any fees or expenses incurred in administering the ICAV and establishing any Intermediary Vehicles including the fees and expenses of the Depositary, the Administrator and any other service provider whether affiliated or not to the AIFM;
 - 6.3.11 any and all expenses arising in respect of the termination or liquidation of the ICAV; and
 - 6.3.12 any and all expenses arising in respect of legal or administrative proceedings concerning the ICAV.
- 6.4 All recurring expenses will be charged against current income or against realised capital gains, and, if need be, against assets of the ICAV as the Directors may from time to time decide.

7 Depositary, AIFM, Investment Manager, Administrator and other Delegates

- 7.1 The ICAV shall forthwith after its registration by the Central Bank and before the issue of any Shares, other than the Subscriber Shares, appoint a person, firm or corporation to act as Depositary with responsibility for the safe-keeping of all of the Investments.
- 7.2 Where the ICAV has appointed an AIFM that is an Authorised AIFM, the terms of appointment of any Depositary may authorise such Depositary to avail of a contractual discharge of liability under the conditions set out in the AIFM Regulations.
- 7.3 The ICAV's property (subject to any exceptions permitted by the Central Bank) shall be entrusted to the Depositary for safekeeping. The types of assets and geographical regions in which the ICAV may invest shall be set out in the Prospectus.
- 7.4 The appointment of the Depositary shall be subject to the approval of the Central Bank. The Central Bank may in its discretion replace the Depositary with another corporation willing to act as Depositary where the Central Bank deems it necessary to do so.
- 7.5 Any termination of the appointment of the Depositary shall only take effect upon the appointment of a successor Depositary or upon the revocation of the authorisation of the ICAV.
- 7.6 If the Depositary shall have given to the ICAV notice of its desire to retire from its appointment or the appointment of the Depositary is terminated pursuant to the terms of this Instrument and no successor shall have been appointed in accordance with this Instrument within such period from the giving of such notice as may be specified in the Depositary Agreement, the

Directors shall, subject to the approval of the Central Bank, repurchase the Shares or appoint a liquidator who shall wind up the ICAV and shall apply, thereafter, to the Central Bank to revoke the authorisation of the ICAV whereupon the Depository's appointment shall terminate.

- 7.7 The ICAV has the power to appoint an entity to act as AIFM and the Directors may entrust to and confer upon the entity so appointed any of the powers, duties, discretions and / or functions exercisable by them as Directors, upon such terms and conditions (including the right to remuneration payable by the ICAV) and with such powers of delegation and such restrictions as they think fit. The appointment of the AIFM (and of any replacement AIFM) shall be in accordance with the requirements of the Central Bank. The Central Bank may in its discretion replace the AIFM with another entity willing to act as AIFM where the Central Bank deems it necessary to do so. In all other cases, the termination of the appointment of the AIFM shall be consistent with the terms of the contract pursuant to which it was appointed and the protection of Shareholders.
- 7.8 The ICAV has the power to appoint a person, firm or corporation to act as Investment Manager. The appointment of the Investment Manager shall be in accordance with the requirements of the Central Bank.
- 7.9 The ICAV has the power to also appoint a person, firm or corporation to act as Administrator. The appointment of the Administrator shall be in accordance with the requirements of the Central Bank.
- 7.10 The ICAV has the power to appoint a person, firm or corporation to act as Distributor. The appointment of the Distributor shall be in accordance with the requirements of the Central Bank.
- 7.11 The ICAV may enter into arrangements with prime brokers or other parties, whereby assets of the ICAV are passed outside of the control of the Depository and may be held as collateral for margin loans or other financing that is provided to the ICAV, held or transferred as collateral in connection with the hedging arrangements entered into on behalf of the ICAV or otherwise utilised by the prime broker for its own purposes, including in connection with securities lending. Under the terms of any such arrangements in relation to the assets of the ICAV being used as collateral and under applicable law, a secured party may be permitted to pledge, lend, rehypothecate or otherwise utilise for its own purposes such assets in connection with securities lending or other transactions entered into by the secured party.
- 7.12 The AIFM (or Investment Manager, as appropriate) will be entitled to receive an investment management fee payable out of the assets of the ICAV as may be agreed between the Directors and the AIFM (or Investment Manager, as appropriate) from time to time and specified in the Prospectus.
- 7.13 In addition to the management fee specified in Section 7.12 above, the AIFM (or Investment Manager, as appropriate) may be entitled to such Performance Fee out of the assets of the ICAV as may be agreed between the Directors and the AIFM (or Investment Manager, as appropriate) from time to time and specified in the Prospectus.
- 7.14 The Directors shall be entitled to pay a fee out of the assets of the ICAV in respect of the promotion and sale of Shares of each Class and related and ancillary services in such amount as may be provided for in the Prospectus.

- 7.15 The Administrator shall be entitled to a fee payable out of the assets of the ICAV in respect of the administrative and transfer agency services provided to the ICAV as may be agreed between the Directors and the Administrator from time to time and specified in the Prospectus.
- 7.16 The Depositary will be entitled to a fee in respect of its custody and safe-keeping services out of the assets of the ICAV as may be agreed between the Directors and the Depositary from time to time and specified in the Prospectus. For the purpose of securing payment of its fees and expenses, in the event of non-payment of such fees and expenses the ICAV may permit the Depositary to charge the assets of the ICAV which are maintained in the ICAV's accounts.
- 7.17 The ICAV may contractually agree with the Depositary that if at any time any and all obligations or liabilities to the Depositary for any unpaid sum due to the Depositary or any sub-custodian or securities system for or in connection with services rendered hereunder whether by way of an extension of credit or otherwise (including without limitation the purchase or sale of any foreign exchange or any agreement for the purchase or sale of foreign currency) shall not have been honoured and shall be overdue, the Depositary and any sub-custodian or securities system may have the right, on such terms as may be agreed between the ICAV and the Depositary, to retain or set-off, against such obligations or liabilities, any assets of the ICAV that the Depositary or any sub-custodian or securities system may hold directly or indirectly for the account of the ICAV, in any currency (including without limitation time deposits and all securities held hereunder) and, to the extent that there is insufficient cash available for this purpose to sell or otherwise realise any such assets and to apply the proceeds of any such sale or realisation in the satisfaction of such obligations or liabilities.
- 7.18 The AIFM (or its delegates) may establish one or more investment advisory committees (each, an "**Advisory Committee**") to consider and, on behalf of a Fund and its Shareholders, approve or disapprove, including for purposes of obtaining any consent or approval of, or on behalf of, Shareholders or a Fund required by applicable law any Fund transaction or other matter or fee and any matters presented to it, including, but not limited to, any transaction or matter involving a possible conflict of interest which the AIFM (or its delegates) determines to present to an Advisory Committee. The membership of an Advisory Committee will be determined from time to time, and will be subject to change, by the AIFM (or its delegates). The consent by any Advisory Committee acting on behalf of a Fund will be deemed to constitute the consent of the Fund and the Shareholders. A Fund may directly provide for or pay for the cost and expense of travel, accommodations, meals and beverages, materials and other costs related to a meeting of an Advisory Committee, and may reimburse the committee members for their expenses. In addition, to the extent an Advisory Committee consists of persons who are not Shareholders or other direct or indirect beneficial owners of interests in a Fund, the relevant Fund will pay the reasonable compensation of such persons for serving on such Advisory Committee, as determined by the AIFM (or its delegate) in its sole discretion. To the extent permitted by applicable law, a committee member will not owe a fiduciary duty to the relevant Fund or its Shareholders. An Advisory Committee will not possess or exercise any power that, if possessed or exercised by a Shareholder, would constitute participation in the control of the business of a Fund. To the extent permitted by applicable law, no member of an Advisory Committee (including any organisation retained to serve as or in place of an Advisory Committee, as described below), nor any Shareholder that has designated a member of an Advisory Committee, will be liable for any act or omission performed or failed to be performed by such person as a member of such

committee or in designating a member of such committee, or for any losses, claims, costs, damages or liabilities arising therefrom, in the absence of wilful misfeasance, bad faith, negligence or criminal wrongdoing. The relevant Fund may indemnify members of an Advisory Committee (including any organisation retained to serve as or in place of an Advisory Committee, as described below) and any Shareholder that has designated a member of an Advisory Committee against any losses, claims, costs, damages or liabilities to which such person may become subject in connection with any matter arising out of or in connection with any act or omission performed or failed to be performed by such person as a member of an Advisory Committee or in designating a member of an Advisory Committee, except to the extent that any such loss, claim, cost, damage or liability results solely from the wilful misfeasance, bad faith or negligence of, or any criminal wrongdoing by, such person.

8 Share Capital

- 8.1 The actual value of the paid up share capital of the ICAV shall at all times be equal to the Net Asset Value of the ICAV as determined in accordance with Sections 21 and 22 hereof.
- 8.2 The share capital of the ICAV shall be equal to the value for the time being of the issued share capital of the ICAV. The ICAV may issue up to 500,000,000,000 (five hundred billion) Shares of no par value and up to 10,000 (ten thousand) Subscriber Shares of no par value issued at €1.00 each. The maximum issued share capital of the ICAV shall be 500,000,000,000 (five hundred billion) Shares of no par value and the minimum issued share capital of the ICAV shall be €2 represented by two Subscriber Shares of no par value issued for €1 each.
- 8.3 The Directors are hereby generally and unconditionally authorised to exercise all the powers of the ICAV to issue Shares in the ICAV provided that the total amount of issued share capital does not exceed the maximum issued share capital set out in Section 8.2 above.
- 8.4 For Capital Commitment Funds, investors may agree to commit a certain amount of capital to the Fund for the purchase of Shares. It is anticipated that, where indicated in the relevant supplement of a Fund, Capital Commitments will be drawn down with respect to each Shareholder over a certain period from the date of entering into such Capital Commitment by any investor. Directors may, at their absolute discretion, draw down Capital Commitments from Shareholders in such ratio or such proportion as the Directors may deem appropriate, and Shareholders may be called on to commit different proportions of their respective Capital Commitments. The ICAV will have the right to terminate any uncalled portion of a Shareholder's Capital Commitment and waive the Shareholder's obligations to make further capital contributions at any time.
- 8.5 For Capital Commitment Funds, capital will generally not be considered contributed to a Fund until actually received by the Fund from the Shareholders; provided, however, that in the ICAV's sole discretion, capital contributions may be considered made to the Fund as of a particular date following that in which such capital contributions are due or actually made, and the ICAV may, in its sole discretion, make other adjustments to the date capital is considered contributed (including in respect of defaulting Shareholders), provided however, capital contributions may only be considered to be made with effect from a Dealing Day falling after the Drawdown Notice is issued.
- 8.6 For Capital Commitment Funds, the ICAV may, at any time, recall any amounts previously distributed to Shareholder for the same purposes, in the same manner and subject to the

same notice requirements as the Fund may call Capital Commitments subject to the conditions, if any, set out in the Prospectus.

- 8.7 The Subscriber Shares shall not participate in the dividends or assets of any Fund.
- 8.8 Shares may be issued with such voting rights and rights to participate in the dividends and assets of a Fund or of the ICAV as the Directors from time to time may determine and set forth in the Prospectus.
- 8.9 The liability of the Shareholders shall be limited to (a) the amount, if any, unpaid on the Shares respectively held by them and (b) for Capital Commitment Funds, the amount of uncalled Capital Commitments, in each case without prejudice to any other liability to which a Shareholder may be subject as provided by or under the Act, the Prospectus or the Subscription Agreement. The Shareholders shall not be liable for the debts of the ICAV.
- 8.10 The Directors may from time to time determine to provide Shareholders in certain Classes with preferential treatment (including but not limited to, in relation to information disclosed to such Shareholders and redemption and dealing terms for such Classes). Any preferential treatment will be set out in the Prospectus (so as to ensure the fair treatment of all Shareholders) which shall describe any instance where a Class receives preferential treatment, a description of that preferential treatment and the types of Shareholders who will be permitted to subscribe for such Classes and, where relevant, their legal or economic links to the ICAV (or the AIFM).

9 Funds and Classes of Shares

- 9.1 The ICAV is an umbrella fund with segregated liability between its Funds and each Fund may be comprised of one or more Classes of Shares. The ICAV is comprised of the Funds specified in the Prospectus, as may be amended from time to time.
- 9.2 With the prior approval of the Central Bank, the Directors from time to time may establish a Fund, which may be open-ended, closed-ended or have limited liquidity, by the issue of one or more separate Classes of Shares on such terms as the Directors may resolve. The creation of such additional Funds and one or more separate Classes of Shares shall be in accordance with this Instrument, the Prospectus and the requirements of the Central Bank.
- 9.3 The ICAV may create and issue different Series of Shares of each Class for the purposes of tracking and more accurately calculating the Performance Fee payable to the Investment Manager in respect of the Shares held by each investor. Any outstanding Series of Shares of a Fund may, in the discretion of the Directors, be re-designated and converted (after the payment or accrual of all applicable fees and expenses) into Shares of another Series of the same Fund at the prevailing Net Asset Value per Share of such other Series.
- 9.4 The investment objectives of (and any specific restrictions applicable to) each Fund are set out in the Prospectus. Subject to any specific provisions set out in respect of a particular Fund in the Prospectus, the investment and borrowing powers of each Fund are all those contained in the AIFM Regulations and permitted under the Act.
- 9.5 A Fund may be wound-up by the Directors in their absolute discretion, as if it were a separate ICAV, if the Directors resolve that it is desirable to terminate the Fund and provided the termination is in accordance with the provisions of Section 40, the Act and the AIFM Rules.

- 9.6 The Directors may from time to time re-designate any existing Class of Shares in the ICAV and merge such Class of Shares with any other Class of Shares in the ICAV, provided that Shareholders in such Class or Classes are first notified by the ICAV and given the opportunity to have the Shares repurchased. With the prior consent of the Directors, Shareholders may convert Shares in one Class of Shares into Shares of another Class in the ICAV in accordance with the provisions of Section 12.15 hereof.
- 9.7 For the purpose of enabling Shares of one Class to be re-designated or converted into Shares of another Class, the ICAV may take such action as may be necessary to vary or abrogate the rights attached to Shares of one Class to be converted so that such rights are replaced by the rights attached to the other Class into which the Shares of the original Class are to be converted.
- 9.8 Any outstanding Classes or series of Shares of a Fund may, in the discretion of the Directors, be redesignated and converted (after the payment or accrual of all applicable fees and expenses) into Shares of another Class or series of the same Fund at the prevailing Net Asset Value per Share of such other Class or series.
- 9.9 Financial instruments may be used on behalf of specific Classes or Classes in accordance with the Prospectus and the requirements of the Central Bank. Where Class Level Transactions are utilised on behalf of a specific Class or Classes in accordance with the requirements of the Central Bank, in each case such Class Level Transactions will be clearly attributable to a specific Class and any costs and any resultant gains / losses of the relevant Class Level Transactions will accrue solely to the relevant Class.
- 9.10 All consideration received by the ICAV for the allotment or issue of Shares of each issue, together with all Investments in which such consideration is invested or reinvested, all income, earnings, profits and proceeds thereof shall be segregated and kept separate in the accounts of the Depository from all other moneys of the ICAV and such assets and moneys shall be referred to as a “Fund”, there being one such Fund in respect of each issue to which the following provisions shall apply:
- 9.10.1 The ICAV shall keep separate books of account for each issue. The proceeds from the issue of Shares of each issue shall be applied to the Fund established for that issue and the assets and liabilities and income and expenditure attributable thereto shall be applied to such Fund subject to the provisions of this section;
- 9.10.2 Any asset derived from another asset comprised in a Fund shall be applied to the same Fund as the asset from which it was derived and any increase or diminution in the value of such an asset shall be applied to the relevant Fund;
- 9.10.3 In the case of any asset which the Directors do not consider as readily attributable to a particular Fund or Funds, the Directors shall have discretion to determine the basis upon which any such asset shall be allocated between Funds and the Directors shall have the power at any time and from time to time to vary such basis;
- 9.10.4 Each Fund shall be charged with the liabilities, expenses, costs, charges or reserves of the ICAV in respect of or attributable to that Fund and any such liabilities, expenses, costs, charges or reserves of the ICAV not readily

attributable to any particular Fund or Funds shall be allocated and charged by the Directors in such manner and on such basis as the Directors in their discretion deem fair and equitable, and the Directors shall have the power to and may at any time and from time to time vary such basis;

9.10.5 If, as a result of a creditor proceeding against certain of the assets of the ICAV or otherwise, a liability, expense, cost, charge or reserve would be borne in a different manner from that in which it has been borne under paragraph 9.10.4 above, or in any similar circumstances, the Directors may, with the consent of the Depositary, transfer in the books and records of the ICAV any assets to and from any of the Funds; and

9.10.6 Subject as otherwise provided in this Instrument, the assets held in each Fund shall be applied solely in respect of the Shares of the issue to which such Fund appertains and shall belong exclusively to the relevant issue and shall not be used to discharge directly or indirectly the liabilities of or claims against any other Fund and shall not be available for any such purpose.

10 Register of Shareholders

10.1 A Shareholder shall have his or her title to Shares evidenced by having his or her name, address and number of Shares held by him or her entered in the Register which shall be maintained in the manner required by law, provided that no person holding less than the Minimum Subscription shall be entered on the Register as a Shareholder. No person shall be registered as a Shareholder of the ICAV unless: (i) such person has subscribed for or acquired shares by transfer to the value of not less than the minimum amount as set out in the AIF Rulebook relating to funds marketing solely to Qualifying Investors (currently €100,000 or the foreign currency equivalent, save in the case of Knowledgeable Investors) and, (ii) shall have certified that he/she is a Qualifying Investor (or a Knowledgeable Investor) and that he/she is aware of the risks involved in the proposed investment and of the fact that inherent in such is the potential to lose all of the sum invested. Where the ICAV has appointed an AIFM that is an Authorised AIFM, the ICAV may only be marketed within the European Union to investors who are professional clients (as defined in the AIFM Regulations) unless the EU member state in question permits, under the laws of that EU member state, the ICAV to be sold to other categories of investors and this permission encompasses the other categories of investors set out in the definition of "Qualifying Investor" or "Knowledgeable Investor" in this Instrument. Where the ICAV has not appointed an AIFM that is an Authorised AIFM, the ICAV may only be marketed investors in accordance with local requirements in the jurisdiction of the relevant investor and where the investors are Qualifying Investors or Knowledgeable Investors.

10.2 The ICAV shall not issue Share certificates to a Shareholder whose name appears in the Register but, in such case, a statement of Shareholding (a "**holding statement**") in respect of Shares for which no certificates are to be issued shall, if so requested by a Shareholder, be sent to each holder of such Shares in such form as the Directors may decide. A holding statement shall be a written confirmation of entry on the Register. A holding statement shall not constitute a document of title to the Shares to which it relates and shall confirm the entry of the Shares in question on the Register.

10.3 The Directors shall cause to be entered in the Register the following particulars:

- 10.3.1 the name and address of each Shareholder (save that in the case of joint holders, the address of the first named holder only need be entered);
 - 10.3.2 a statement of the number of Shares held by each Shareholder, which statement shall distinguish each Share by its number (if any), the Fund and the Class of Shares (if any) of such Fund to which the Share belongs, and of the amount paid or agreed to be considered as paid on such Shares;
 - 10.3.3 the date on which each person was entered in the Register as a Shareholder, and
 - 10.3.4 the date on which any person ceased to be a Shareholder.
- 10.4 The Register:
- 10.4.1 shall be kept in such manner as to show at all times the Shareholders of the ICAV for the time being and the Shares respectively held by them;
 - 10.4.2 shall be kept available for inspection in accordance with the Act.
- 10.5 The Directors shall not be bound to register more than four persons as the joint holders of any Share or Shares. In the case of a Share held jointly by several persons, the Directors shall not be bound to issue therefor more than one confirmation of ownership and the issue of a confirmation of ownership for a Share to the first named of several joint holders shall be sufficient delivery to all.
- 10.6 Where two or more persons are registered as the holders of any Shares they shall be deemed to hold the same as joint tenants, subject to the provisions following:
- 10.6.1 the joint holders of any Shares shall be liable, severally, as well as jointly, in respect of all payments which ought to be made in respect of such Shares;
 - 10.6.2 any one of such joint holders may give effectual receipts for any dividend, bonus or return of capital payable to such joint holders;
 - 10.6.3 only the first-named of the joint holders of a Share shall be entitled to receive notices from the ICAV to attend general meetings of the ICAV. Any notice given to the first-named of joint holders shall be deemed notice given to all the joint holders;
 - 10.6.4 the vote of the first-named of joint holders who tenders a vote whether in person or by proxy shall be accepted to the exclusion of the votes of the other joint holders; and
 - 10.6.5 for the purpose of the provisions of this section, the first-named shall be determined by the order in which the names of the joint holders stand in the Register.
- 10.7 In the case of the death of a Shareholder, the survivors or survivor where the deceased was a joint holder, and the executors or administrators of the deceased where he/she was a sole or surviving holder, shall be the only person recognised by the ICAV as having title to his/her interest in the Shares, but nothing in this Section shall release the estate of the deceased

holder whether sole or joint from any liability in respect of any Share solely or jointly held by him/her.

- 10.8 Any guardian of an infant Shareholder and any guardian or other legal representative of a Shareholder under legal disability and any person entitled to a Share in consequence of the death, insolvency or bankruptcy of a Shareholder shall, upon producing such evidence of his/her title as the Directors may require, have the right either to be registered himself/herself as the holder of the Share or to make such transfer thereof as the deceased or bankrupt Shareholder could have made, but the Directors shall, in either case, have the same right to refuse or suspend registration as they would have had in the case of a transfer of the Share by the infant or by the deceased, insolvent or bankrupt Shareholder before the death, insolvency or bankruptcy or by the Shareholder under legal disability before such disability.
- 10.9 A person so becoming entitled to a Share in consequence of the death, insolvency or bankruptcy of a Shareholder shall have the right to receive and may give a discharge for all monies payable or other advantages due on or in respect of the Share, but he/she shall not be entitled to receive notice of or to attend or vote at meetings of the ICAV, nor save as aforesaid, to any of the rights or privileges of a Shareholder unless and until he/she shall be registered as a Shareholder in respect of the Share **PROVIDED ALWAYS** that the Directors may at any time give notice requiring any such person to elect either to be registered himself/herself or to transfer the Share and if the notice is not complied with within ninety (90) days the Directors may thereafter withhold all moneys payable or other advantages due in respect of the Share until the requirements of the notice have been complied with.

11 **Dealing Days**

Subject as hereinafter provided, all issues and repurchases of Shares shall be effected or made with effect from a Dealing Day provided that the ICAV may provisionally allot Shares on a Dealing Day on the basis that the Shares shall be issued on receipt of cleared subscription monies and in the event that the ICAV does not receive the cleared subscription monies in respect of such allotment within the period specified in the Prospectus or within such other reasonable time period as may be determined by the Directors, such provisional allotment may be cancelled.

12 **Issue of Shares and Conversion of Shares**

- 12.1 Subject as hereinafter provided, the ICAV on or with effect from any Dealing Day on receipt by it of the following:
- 12.1.1 an application for Shares in such form as the ICAV from time to time may determine; and
 - 12.1.2 such declarations as to the applicant's status, residence and otherwise as the ICAV from time to time may require (including, inter alia, any declarations or information required pursuant to anti-money laundering or counter terrorist financing requirements or pursuant to the Beneficial Ownership Regulations); and
 - 12.1.3 payment for the Shares within the usual time limits in such manner as the ICAV from time to time may specify, provided that if the ICAV receives payment for the Shares in a currency other than the Class Currency for such Shares, the ICAV shall convert or arrange for the conversion of the monies received into the Class

Currency and shall be entitled to deduct therefrom all expenses incurred in the conversion;

may issue or allot Shares in any Class at the Net Asset Value then obtaining for each Share in such Class (or if a new series is being issued, at such offer price as may be determined by the Directors, or their delegates) or at such other price as may be disclosed in the Prospectus from time to time. Any such issue of Shares shall be in accordance with the requirements of this Instrument, the Prospectus and the requirements of the Central Bank.

- 12.2 The declarations referred to in Section 12.1.2 (the “**Status Declarations**”) may include declarations as to whether or not the applicant (or a person on behalf, or for the benefit, of whom the applicant holds Shares) is an Irish Resident, US Person, Permitted US Person, Benefit Plan Investor, Qualifying Investor, Knowledgeable Investor and/or Exempt Investor.
- 12.3 The ICAV shall be entitled to receive securities or other Investments from an applicant for Shares in any Class and to sell, dispose of or otherwise convert such securities or Investments into cash and to apply such cash (net of any expenses incurred in the conversion) for the purchase of Shares in the ICAV in accordance with the provisions hereof.
- 12.4 No issue shall be made in respect of an application which would result in the applicant investing less than the Minimum Subscription or in the Shares being held by a person who is not a Qualifying Investor (save in both cases in respect of a Knowledgeable Investor or the holder(s) of the Subscriber Shares).
- 12.5 All information required under the AIFM Rules as specified in the Prospectus will be made available to prospective investors prior to subscriptions being accepted.
- 12.6 The Directors shall be entitled to issue Fractional Shares in any Class where the subscription monies received by the ICAV are insufficient to purchase an integral number of Shares in that Class.
- 12.7 The Directors may determine to issue Shares which are only partly paid at the time of issue, subject to such conditions as may be specified in the Prospectus.
- 12.8 The Directors may delegate to the Administrator or to any duly authorised Officer or other person, the duties of accepting the subscription for, receiving payment for and allotting or issuing new Shares.
- 12.9 The Directors in their absolute discretion may refuse to accept any application for Shares in the ICAV or any application to convert Shares in any Class to Shares in another Class or may accept any such application in whole or in part.
- 12.10 For Capital Commitment Funds and during the Commitment Period, the ICAV may require a Shareholder to subscribe for Shares in a Fund, provided that no Shareholder shall be requested to subscribe an aggregate amount in excess of its Capital Commitment. The ICAV shall issue a Drawdown Notice and investors who do not meet their obligations under a Drawdown Notice will be in Default (as defined below).
- 12.11 If a Shareholder fails to make a required capital contribution or other required payment to the Fund (including as a result of a failure to fund a brokerage account held with the AIFM or one of its affiliates) or other required payment on such dates shall be specified in the Prospectus, or fails to comply with any term or condition set forth in this Instrument of

Incorporation or the Shareholder's Subscription Agreement, the Shareholder shall be in default (a "**Default**"); provided that the ICAV, in its sole discretion, may waive any Default.

- 12.12 Upon a Default by a Shareholder, such defaulting Shareholder will be required to indemnify the Fund, the AIFM, the Investment Manager, any investment advisor and any of their respective affiliates in such terms as may be set out in the Prospectus.
- 12.13 No person shall be recognised by the ICAV as holding any Shares on trust and the ICAV shall not be bound by or recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any Shares or (except only as otherwise provided herein or as by law may be required) any other right in respect of any Share, except an absolute right of title thereto in the registered holder.
- 12.14 If at any time the Directors determine, in their sole discretion, that an incorrect number of Shares was issued to a Shareholder pursuant to this section (including because the Net Asset Value in effect on the Dealing Day was incorrect), the Directors may implement such arrangements as they determine, in their sole discretion, are required for an equitable treatment of such Shareholder, which arrangements may include redeeming a portion of such Shareholder's shareholding for no additional consideration or issuing new Shares to such Shareholder for no consideration, as appropriate, so that the number of Shares held by such Shareholder following such redemption or issuance, as the case may be, is the number of Shares as would have been issued at the correct Net Asset Value.
- 12.15 Subject as hereinafter provided, a holder of Shares of any Class (the "**Original Shares**") may, with the prior consent of the Directors, from time to time convert all or any portion of such Shares ("**Conversion**") having such minimum value at the time of Conversion as may be determined by the Directors from time to time into Shares of another Class (the "**New Shares**") either existing or agreed to be brought into existence on such terms as are disclosed in the Prospectus. Any Original Shares of a Fund may also, in the discretion of the Directors, be converted into New Shares of the same Fund at the prevailing Net Asset Value per Share of such other New Shares in circumstances set out in the Prospectus.
- 12.16 The Directors may, in the circumstances described in the Prospectus, from time to time convert (after the payment or accrual of all applicable fees and expenses) all or any portion of a Shareholder's Shares into Shares of another Class or Series at the prevailing Net Asset Value per Share of such other Class or Series.

13 **Rights Attached to Shares**

- 13.1 The assets of the ICAV shall belong exclusively to the ICAV and no Shareholder shall have any interest in the underlying assets of the ICAV.
- 13.2 The rights which attach to each Share of any given Class are as follows:
- 13.2.1 the right, in accordance with this Instrument, to participate in or receive profits or income arising from the acquisition, holding, management or disposal of ICAV property;
- 13.2.2 the right, in accordance with this Instrument, to vote at any annual general meeting of Shareholders of the ICAV or at any meeting of the Shareholders of a Class of Shares; and

- 13.2.3 such other rights as may be provided for in this Instrument in relation to Shares of that Class, subject to the regulations and conditions imposed by the Central Bank.

14 Price Per Share

- 14.1 The Initial Price per Share at which the Shares of any Class or Series shall be allocated or issued and the commission payable on the Initial Price and the Initial Offer Period in relation to any Fund shall be determined by the Directors.
- 14.2 The price per Share for any Class or Series of Shares on any Dealing Day following the Initial Offer Period shall be the Net Asset Value per Share in such Class or Series applicable in the case of issues of Shares in such Class or Series as determined at the relevant Valuation Point (or if Shares of a new Series are being issued, at such offer price as may be determined by the Directors, or their delegates) in accordance with Section 21 and Schedule 2 (being a Valuation Point after the receipt of the dealing request for the given Dealing Day) or such other price as may be determined by the Directors and disclosed in the Prospectus from time to time.
- 14.3 Shares may only be issued at fixed price after the Initial Offer Period where existing Shareholders of the relevant Fund will not be prejudiced.
- 14.4 The Directors may require an applicant for Shares to pay to the ICAV in addition to the price per Share such commission and duties and charges in respect of the Shares as the Directors from time to time may determine.
- 14.5 Notwithstanding any other provision of this Instrument, in calculating the price per Share for any Class of Shares on any Dealing Day when there are net subscriptions the Directors, or their delegate, may adjust the subscription price by adding an anti-dilution levy to cover dealing costs and to preserve the value of the underlying assets of the relevant Fund.
- 14.6 Subject to the provisions of the Act and the AIF Rulebook, the Directors on or with effect from any Dealing Day may issue Shares in any Class on terms providing for settlement to be made by the vesting in the Depositary, on behalf of the ICAV of any Investments for the time being held or which may be held hereunder and in connection therewith the following provisions shall apply:
- 14.6.1 the assets to be transferred in to the Fund must qualify as investments of the Fund in accordance with the investment objectives, policies and restrictions which are set out in the Prospectus;
- 14.6.2 the Directors shall be satisfied that the terms of any such exchange shall not be such as are likely to result in any material prejudice to the Shareholders;
- 14.6.3 the number of Shares to be issued shall be not more than the number which would have been issued for settlement in cash as hereinbefore provided on the basis that the amount of such cash was an amount equal to the value of the Investments to be so vested in the ICAV as determined by the Directors on the relevant Dealing Day;
- 14.6.4 no Shares shall be issued until the Investments shall have been vested in, or arrangements have been made to vest the Investments in, the Depositary or its

sub-custodian, nominee or agent and the Depositary is satisfied that there is unlikely to be any material prejudice to the Shareholders of the relevant Fund; and

- 14.6.5 any duties and charges arising in connection with the vesting of such Investments in the ICAV shall be paid by the person to whom the Shares are to be issued, or by the relevant Fund.
- 14.7 No Shares shall be issued on any Dealing Day on which the determination of the Net Asset Value of such Shares is suspended pursuant to Section 21.11 hereof.
- 14.8 Notwithstanding any other provision of this Instrument in calculating the price per Share on any Dealing Day in respect of any Class in respect of which it has been determined to charge a Performance Fee, the Directors may from time to time, and in their sole discretion, determine that the ICAV shall apply a Performance Fee equalisation formula and will disclose details of such intention in the Prospectus. In such circumstances, the price per Share of the relevant Shares will be deemed to include an equalisation amount which will represent a portion the accrued Performance Fee of the relevant Class up to the date of the subscription.

15 **Qualified Holders**

- 15.1 The ICAV may, at its discretion and for any or no reason, reject any subscription for, transfer of or sale (other than by way of repurchase) of Shares.
- 15.2 The ICAV may from time to time impose such restrictions as it thinks necessary for the purposes of ensuring that no Shares of the ICAV are acquired or held by any person in circumstances:
- 15.2.1 which constitute a breach of the law or governmental regulation (or any interpretation of a law or regulation by a competent authority) of any country or territory; or
- 15.2.2 which would (or would if other Shares were acquired or held in like circumstances) result in the ICAV or any of its Shareholders suffering (in the opinion of the Directors) an adverse consequence (including a requirement to register under any securities or investment or similar laws or governmental regulation of any country or territory or a liability to tax) or a material disadvantage; or
- 15.2.3 in which the person, in the opinion of the Directors, is either (a) a US Person who is not a Permitted US Person or (b) holds Shares on behalf of or for the benefit of a US Person who is not a Permitted US Person; or
- 15.2.4 which constitutes a breach of this Instrument, the Subscription Agreement or the Prospectus as to eligibility or entitlement to hold such Shares.
- 15.3 Where the Directors, in their absolute discretion, consider that a person is holding Shares in one of the circumstances listed in Section 15.2 above (or where they have reason to believe this to be the case), the Directors may exercise the powers set out in Schedule 1 to this Instrument. Schedule 1 to this Instrument also sets out certain obligations of Shareholders.

16 Transfer and Transmission of Shares

- 16.1 All transfers of Shares shall be effected by a transfer in writing in any usual or common form and every form of transfer shall state the full name and address of the transferor and transferee.
- 16.2 The instrument of transfer shall be signed by or on behalf of the transferor and need not be signed by the transferee, and shall meet such requirements as may be specified in the Prospectus or as may otherwise be required by the Directors to prove the right of the transferor to transfer the Shares. The transferor shall be deemed to remain the holder of the Share until the name of the transferee is entered in the Register in respect thereof.
- 16.3 A transfer of Shares may not be registered if such transfer would result in the transferor or the transferee holding a number of Shares less than the Minimum Subscription or the Minimum Holding. Only transferees who certify that they are Qualifying Investors or Knowledgeable Investors and that they are aware of the risk involved in the proposed investment and that inherent in such investment is the potential to lose all of the sum invested, shall be entered on the Register as a Shareholder and shall be permitted to invest in the ICAV. The Directors shall not register a transfer of Shares unless the transferee is a Qualifying Investor or Knowledgeable Investor and has provided such evidence of identity and / or status as the ICAV or its delegates may require.
- 16.4 The Directors may decline to register any transfer of Shares for any or no reason, including where the transfer would result in a contravention of any provision of this Instrument or would produce a result inconsistent with any provision of the Prospectus or where the transferee fails to provide the necessary declarations as to tax residency as may be requested by the ICAV.
- 16.5 If the Directors decline to register a transfer of any Share they shall, within two months after the date on which the instrument of transfer was lodged with the ICAV, give to the transferee written notice of the refusal (but without being required to provide any reason therefor). For the avoidance of doubt, the Directors are not required to register a transfer or give notice to any person of a refusal to register a transfer where registering the transfer or giving the notice would result in a contravention of any provision of any law (including any law that is for the time being in force in a country or territory other than the State).
- 16.6 The registration of any transfers may be suspended at such times and for such periods as the Directors from time to time may determine, **PROVIDED ALWAYS** (but subject to Section 21.11 below) that such registration of transfers shall not be suspended for more than thirty days in any year.
- 16.7 All instruments of transfer which shall be registered shall be retained by the ICAV, but any instrument of transfer which the Directors may decline to register shall (except in the case of fraud) be returned to the person depositing the same.

17 Investor Commitments

- 17.1 Where Shares are issued on a Commitment basis only, the following provisions shall apply:
- 17.1.1 successful applicants shall be required to undertake irrevocably to subscribe and pay for fully paid Shares in the ICAV when required to do so by the Directors, the AIFM or its delegate in accordance with this Section 17 and Section 18.

- 17.1.2 Shareholders may be called on to pay for Shares for a period as set out in the Prospectus or relevant Supplement. Amounts drawn against each Shareholder's Commitment will be applied as determined by the Directors or the AIFM or its delegate.
- 17.1.3 The Directors may, or the AIFM or its delegate may if directed to do so by the Directors, open the Fund to additional subscription and/or obtain additional Capital Commitments to purchase Shares from new investors and/or existing Shareholders on any Subsequent Closing.
- 17.1.4 The Directors may determine that all or any free cash flow, interest payments and/or other income (as determined by the Directors) net of such amounts as the Directors shall determine, shall be distributed to existing Shareholders immediately prior to any Subsequent Closing.
- 17.1.5 The Directors may determine that new Shares issued on Subsequent Closings shall be issued in accordance with the requirements of the Central Bank at the subscription price for the relevant Class as determined by the Directors or at the Initial Price and that, in addition, where Shares are to be issued at the initial price on Subsequent Closings, an investor or Shareholder subscribing for Shares at Subsequent Closings (or increasing its Commitment) will, on subscription, advance (a) a sum equaling the aggregate amount which would have been drawn down had he subscribed on the Initial Closing Date, together with interest on such amount at the rate of interest determined by the Directors and set out in the Prospectus or relevant Supplement; and (b) a sum equaling any management fees and expenses which he would have been required to bear had he subscribed on the Initial Closing Date together with interest at such rate as determined by the Directors and set out in the Prospectus or relevant Supplement. The Directors may determine that sums representing interest payable under (a) and (b) above are payable in addition to a Shareholder's Commitment. The Directors may determine that existing Shareholders will be paid by means of a distribution that part of the sums drawn down under (a) above as represents the difference between the amounts actually drawn down with a pro-rata share of the interest from existing Shareholders and the amounts that would have been drawn down if the subsequent Shareholder had been admitted on the Initial Closing Date, together paid under (a) above. The Directors may determine that any such repayment will not be treated as having been advanced, and will therefore be available for draw down again. The Directors may determine that amounts paid under (b) above will be paid to the AIFM or its delegate.
- 17.1.6 The Directors may, if so disclosed in the Prospectus or relevant Supplement, excuse an investor from its obligation to purchase Shares pursuant to a Commitment upon due notice of a drawdown request if: (a) as a result of an event that is applicable to the Fund or the investor and cannot reasonably be avoided, the investor's shareholding gives rise to a violation or breach of law (or regulation having the force of law) in its principal place of business or incorporation which: (i) makes it unlawful for such investor to continue to fund calls on its Commitment for the purposes of funding Investments or to hold Shares (or portions thereof), or (ii) gives rise to any material taxes or penalties imposed on it, and (b) the investor provides a legal opinion issued by legal counsel in a form and content

reasonably acceptable to the Directors or their delegate to the effect that such breach or violation has occurred.

18 Drawdowns

18.1 Where Shares are issued on a Commitment basis only, the following provisions shall apply:

18.1.1 The Directors, the AIFM or its delegate, will make a call on Capital Commitments (a “**Drawdown**”) in accordance with the provisions, procedures and time frames set down in the Prospectus or relevant Supplement.

18.1.2 Other than as may be required to pay costs, expenses and liabilities of the Fund, the ICAV may, if determined by the Directors, cancel all undrawn Capital Commitments (if any) following the disposal of all of the assets of the Fund or as may otherwise be determined by the Directors and set out in the Prospectus or relevant Supplement.

18.1.3 Following the expiry of the Investment Period, the ICAV may not make further Drawdowns for Capital Commitments for the purpose of acquiring new Investments, however, undrawn Capital Commitments may be drawn upon for the purpose of:

- (a) paying the management fees and expenses and the operating costs of the relevant Fund;
- (b) completing Investments by the Fund for which a binding commitment to invest was in place before the end of the Investment Period and to make follow-on Investments;
- (c) such other purposes as determined by the Directors and set out in the Prospectus or relevant Supplement.

18.2 Investors’ remaining undrawn Capital Commitments will be cancelled by such date after the Final Closing Date as the Directors may determine and specify in the Prospectus or relevant Supplement.

18.3 If an investor fails to make a Capital Contribution as required in a Drawdown Notice, the Directors may, at any time thereafter during such time as such failure continues, serve a written notice on such investor requiring such failure to be remedied (together with interest thereon) (the “**Default Notice**”). The Default Notice shall identify a further date on or before which the payment required by the Default Notice is to be made and shall state that, in the event of non-payment at or before the time appointed (a “**Default**”), the investor may be designated by the Directors as in default (a “**Defaulting Investor**”). The Directors may take any or all of the following actions with respect to a Defaulting Investor: (i) require a transfer of the Defaulting Investor’s Shares of the applicable Class; (ii) require Defaulting Investors to indemnify the Fund, the AIFM, any Investment Manager for any and all costs, losses and expenses incurred as a result of the Default; (iii) cause the Defaulting Investor’s Shares to be compulsorily redeemed or transferred, as applicable; (iv) apply amounts otherwise distributable to such Defaulting Investor in satisfaction of all amounts payable by such Defaulting Investor; (v) charge such Defaulting Investor interest on any amount that is in Default and any other amounts not timely paid from the date such amounts were due and payable through the date that full payment of such amounts is actually made and to the

extent not paid such interest charge may be deducted from amounts otherwise distributable to such Defaulting Investor; (vi) cancel all or part of the Defaulting Investor's undrawn Capital Commitments and, if so determined at the discretion of the Directors, arrange for such undrawn Capital Commitments to be assumed by another party; and/or (vii) any other action permitted under the laws of Ireland. In addition, the Directors may at their discretion prohibit such Defaulting Investor from making further Capital Commitments. Whenever the vote, consent or decision of the Defaulting Investor is required or permitted pursuant to the Instrument, unless otherwise agreed by the Directors and the Defaulting Investor or required by Irish law, a Defaulting Investor shall not be entitled to participate in such vote, or to make such decision, and such vote or decision shall be tabulated or made as if such Defaulting Investor were not a Shareholder. The Directors may require any defaulting Shareholder to indemnify and keep the Fund, the AIFM, any Investment Manager, the Administrator and the Depositary indemnified against any loss arising from or in connection with such default. The Directors shall have the right to pursue all remedies at law or in equity available to them with respect to the Default of a Defaulting Investor.

19 Repurchase of Shares

- 19.1 The ICAV may repurchase its own outstanding fully paid Shares at any time in accordance with the conditions imposed by the Central Bank and the rules and procedures set out herein and in the Prospectus. A Shareholder may at any time irrevocably request the ICAV to repurchase all or any part of his/her Shares in the ICAV by forwarding a request for repurchase of Shares to the ICAV and, save as otherwise provided in the Prospectus, a repurchase request shall be effective on the Dealing Day following receipt of the repurchase request. This notwithstanding, the ICAV may create limited liquidity Funds where Shareholders have limited rights to request the repurchase of their Shares as provided for in the Prospectus, and may create closed-ended Funds where Shareholders have no right to request the repurchase of their Shares, subject to any conditions set down by the Central Bank.
- 19.2 A request for repurchase of Shares shall be in such form as the ICAV shall prescribe, shall be irrevocable (without the consent of the ICAV) and shall be filed by a Shareholder in written form at the registered office of the ICAV, or at the office of the person or entity from time to time designated by the ICAV as its agent for the repurchase of Shares, and, at the request of the ICAV shall be accompanied by proper evidence of succession or assignment satisfactory to the ICAV, if applicable.
- 19.3 On receipt of a duly completed request for repurchase of Shares, the ICAV shall repurchase the Shares as requested on the Dealing Day on which the repurchase request is effective subject to any suspension of this repurchase obligation pursuant to Section 21.11 hereof. Shares in the capital of the ICAV which are repurchased by the ICAV shall be cancelled. For the avoidance of doubt, Shares held by one Fund in another Fund shall not be cancelled.
- 19.4 The repurchase price per Share in any Class or Series of Shares shall be the Net Asset Value per Share in that Class or Series applicable in the case of a repurchase of such Share obtaining on the Dealing Day on which the repurchase request is effective, less such commission and duties and charges as may be set out in the Prospectus such commission, in the case of open-ended Funds, shall not exceed 5% of the Net Asset Value of the Shares subject to repurchase.

- 19.5 Notwithstanding any other provision of this Instrument, in calculating the repurchase price per Share for any Class or Series of Shares on any Dealing Day when there are net redemptions the Directors, or their delegate, may adjust the repurchase price by deducting an anti-dilution levy to cover dealing costs and to preserve the value of the underlying assets of the relevant Fund.
- 19.6 Payment to a Shareholder under this Section will ordinarily be made in the relevant Class Currency, or at the discretion of the Directors in any other freely convertible currency at the rate of exchange for conversion on the date of payment and shall be despatched no later than 90 days following acceptance of the repurchase request as provided for in Section 19.1 above, except in the case of a limited liquidity or closed-ended fund, where payment shall be made in accordance with the time limits set out in the Prospectus.
- 19.7 On repurchase of part only of the Shares held by any Shareholder, the Directors shall procure that evidence of ownership shall be issued free of charge for the balance of such Shares if so requested by a Shareholder.
- 19.8 In the event that a repurchase of part only of a Shareholder's holding of Shares leaves the Shareholder holding less than the Minimum Subscription or the Minimum Holding, the Directors may, if they think fit, repurchase the whole of that Shareholder's holding.
- 19.9 If the ICAV receives requests for the repurchase of Shares in respect of 10% (or 25% in the case of a Fund with quarterly or less frequent redemption facilities, or such other amount in respect of a limited liquidity Fund as the Directors may determine) or more of the outstanding Shares (by number or value) of any Fund on any Dealing Day, the Directors may elect to restrict the total number of Shares of that Fund to be repurchased to 10% (or such other amount, as appropriate) of the outstanding Shares (by number or by value) in that Fund, in which case all the relevant requests will be scaled down pro rata to the number of Shares requested to be repurchased. The balance of such Shares will be repurchased on the next Dealing Day, subject to the provisions of this Section 19.9, and such Shares shall be repurchased, as disclosed in the Prospectus, either (a) rateably or (b) in priority to any other Shares to be repurchased on that Dealing Day.
- 19.10 A distribution in respect of a redemption may also be made in kind, at the discretion of the Directors, after consultation with the AIFM, provided that where the redemption request represents less than 5% of the Net Asset Value of a Fund, the redemption in kind will only be made with the consent of the redeeming Shareholder. The assets to be transferred shall be selected at the discretion of the Directors with the approval of the Depositary and taken at their value used in determining the redemption price of the Shares being so repurchased. As a result, such distributions will only be made if the Depositary is satisfied that the terms of the distribution will not be such as are likely to result in any material prejudice to the Shareholders in the ICAV. Shareholders will bear any risks of the distributed securities and may be required to pay a brokerage commission or other costs in order to dispose of such securities. If a Shareholder so requests, the AIFM shall sell the assets to be distributed to that Shareholder and distribute the net cash proceeds to the Shareholder.
- 19.11 Redemptions in specie will only be accepted by the ICAV where the Depositary is satisfied that the terms of the exchange will not be such as are likely to result in any material prejudice to Shareholders in the relevant Fund.

- 19.12 At any time after the issue of Shares, the ICAV shall be entitled to repurchase the Subscriber Shares or to procure the transfer of the Subscriber Shares to any person who may be a qualified holder of Shares in accordance with Section 15 hereof.
- 19.13 The Directors shall be entitled, at any time and for any or no reason (including in the event that the ICAV is required to account for, deduct or withhold tax on a disposal of Shares by a Shareholder (whether upon a repurchase of Shares, a transfer of Shares or otherwise) or upon payment of a distribution to a Shareholder (whether in cash or otherwise)) to require the compulsory repurchase and cancellation of all or part of the Shares of any Shareholder. Where such repurchase is for the purposes of obtaining sufficient monies to discharge any such tax liability, the Directors shall instruct the Depositary to place the repurchase proceeds received in respect of such a repurchase of Shares in a separate account so that such monies are separately identifiable for the purposes of discharging any applicable tax liability as aforesaid.
- 19.14 The ICAV may also compulsorily redeem Shares in order to discharge performance related fees which are due and payable to the AIFM and / or the Investment Manager, in such circumstances as are set out in the Prospectus from time to time.
- 19.15 The circumstances in which the Directors may require the compulsory repurchase and cancellation of all or part of the Shares of any Shareholder pursuant to Section 19.13 include, without limitation, those where (i) there is any breach of a Shareholder's representations, warranties or covenants in the Subscription Agreement or related documents executed by such Shareholder; (ii) a Shareholder (a) engages in illegal conduct or gross misconduct which the ICAV determines could result in reputational harm to a Fund, the AIFM or its affiliates or other funds managed by it; (b) is convicted of, or pleads nolo contendere to, a felony or serious misdemeanour; or (c) illegally or fraudulently obtains funds which the Shareholder seeks to invest; or (iii) the Shareholder has violated the applicable restrictions on transfer of Shares.
- 19.16 If at any time after a redemption of Shares pursuant to this section (including in connection with any complete redemption of Shares by a Shareholder), the Directors determine, in their sole discretion, that the amount paid to such Shareholder or former Shareholder pursuant to such redemption was materially incorrect (including because the Net Asset Value at which the Shareholder or former Shareholder purchased such shares was incorrect), the Directors may pay to such Shareholder or former Shareholder any additional amount that the Directors determine such Shareholder or former Shareholder was entitled to receive, or, in the Directors sole discretion, seek payment from such Shareholder or former Shareholder of (and such Shareholder or former Shareholder shall be required to pay) the amount of any excess payment that the Directors determine such Shareholder or former Shareholder received, in each case without interest right to redeem Shares. The Directors may, in their sole discretion, determine to redeem a portion of such Shareholder's shareholdings (if available) for no additional consideration so that the number of Shares held by such Shareholder following such redemption is the number of Shares as would have been issued at the correct Net Asset Value. In the event that the Directors elect not to seek the payment of such amounts from a Shareholder or former Shareholder or is unable to collect such amounts from a Shareholder or former Shareholder, the Net Asset Value will be less than it would have been had such amounts been collected.
- 19.17 Where the ICAV receives a request for the repurchase of Shares from any Shareholder in respect of which the ICAV is required to account for, deduct or withhold taxation, the ICAV

shall be entitled to deduct from the proceeds of repurchase such amount of taxation as the ICAV is required to account for, deduct or withhold and shall arrange to discharge the amount of taxation due.

- 19.18 Where a closed-ended or limited-liquidity Fund proposes to amend the maximum redemption fee or maximum annual fee charged by the Investment Manager disclosed in the Prospectus and paid directly out of the assets of such Fund, the approval of such increase by 75% of votes cast in favour of the increase where there is no realistic opportunity to redeem a shareholding, and in all other circumstances, by 50% of the votes cast.
- 19.19 In connection with any closed-ended Fund established by the ICAV, at the end of such closed-ended period as may be disclosed in the Prospectus, relevant Shareholders in such Fund may be given the opportunity to vote on a Special Resolution to extend such closed-ended period in accordance with the requirements of the Central Bank. In the event that no such Special Resolution is passed at the end of the closed-ended period, or any extended closed-ended period, if applicable, then the ICAV undertake one of the following actions:
- 19.19.1 redeem all outstanding Shares of such Fund and thereafter will apply to the Central Bank for revocation of the Fund's approval;
 - 19.19.2 convert to an open-ended Fund the relevant details of which will be disclosed in the Prospectus;
 - 19.19.3 obtain Shareholder approval to extend the closed-ended period for a further finite period. However, where a redemption facility is available to those Shareholders who do not wish to extend the closed-ended period, an Ordinary Resolution shall be sufficient to extend the closed-ended period.
- 19.20 Unless terminated earlier in accordance with the provisions of the Prospectus or relevant Supplement, or extended as provided for herein, the Term of a Fund will be set out in the Prospectus or relevant Supplement.
- 19.21 Capital may be returned to Shareholders through:
- 19.21.1 compulsory redemptions of Shares on a pro rata basis; and/or
 - 19.21.2 distributions by way of dividend in respect of Shares.
- 19.22 Such capital returns may be made in one or more tranches and the Directors may specify redemption dates and special distribution record dates for these purposes. Shareholders will be notified of compulsory redemptions and dividends by or on behalf of the ICAV.
- 19.23 Prior to the expiry of the Term, all, but not some, of the Shares of a Fund may be redeemed if the Directors determine in good faith that such action would be advisable and in the best interests of a majority of the Shareholders as a result of a material change in the legal or regulatory status of the Fund, provided that they provide not less than four weeks' notice to Shareholders of their intention to compulsorily redeem such Shares.

20 **Total Repurchase**

- 20.1 The ICAV may redeem all of its Shares or the Shares of any Fund or Class in issue if:

- 20.1.1 the redemption of the Shares in a Class or Fund is approved by a resolution in writing signed by all of the holders of the Shares in that Class or Fund, as appropriate, or is approved by a Special Resolution of all of the holders of the Shares in that Class or Fund, as appropriate;
 - 20.1.2 the Net Asset Value of the Fund, or of a Class of Shares in a Fund, does not exceed or falls below such amount as may be determined from time to time by the Directors;
 - 20.1.3 the Directors deem it appropriate because of adverse political, economic, fiscal, regulatory or other factors affecting the ICAV or relevant Class or Fund of Shares;
 - 20.1.4 where the Depositary has served notice of its intention to retire and an alternative depositary has not been appointed within 90 days from the date of such notice; or
 - 20.1.5 in such other circumstances as may be set out in the Prospectus from time to time.
- 20.2 Where a repurchase of Shares pursuant to Section 17 or 20 would result in the number of Shareholders falling below two or such other minimum number of Shareholders as the Act may stipulate as the legal minimum number of Shareholders in an ICAV or would result in the issued share capital of the ICAV falling below such minimum amount as the ICAV may be obliged to maintain as the Act may stipulate, the ICAV may defer the repurchase of such Shares the repurchase of which would result in such number or amount not being satisfied until the ICAV is wound up or until the ICAV procures the issue of sufficient Shares to ensure that the aforesaid number and amount are satisfied. The ICAV shall be entitled to select the Shares for such deferred repurchase in such manner as it may deem to be fair and reasonable and as may be approved by the Depositary.

21 **Determination of Net Asset Value and Temporary Suspension of Dealings**

- 21.1 The ICAV shall determine the Net Asset Value of the ICAV and each Fund as at each Valuation Point. The Net Asset Value shall be expressed in the Base Currency as a per Share figure for the issue of Shares and for the repurchase of Shares, respectively as appropriate.
- 21.2 The Net Asset Value per Share of the ICAV shall be calculated by dividing the assets of the ICAV less its liabilities by the number of Shares in issue and shall be determined in accordance with Section 22 and Schedule 2 hereof.
- 21.3 The Net Asset Value per Share in respect of a Fund which is not divided into different Classes will be calculated by dividing the Net Asset Value of the relevant Fund by the number of Shares of the relevant Fund in issue.
- 21.4 In the event that a Fund is divided into different Classes, the amount of the Net Asset Value of the Fund attributable to a Class shall be determined by allocating all relevant fees and expenses to the relevant Class, making appropriate adjustments to take account of distributions, subscriptions, redemptions, gains and expenses of that Class and apportioning the Net Asset Value of the Fund accordingly.

- 21.5 Where the Directors have created different Classes and have determined that (i) each Class or Classes will incur different levels of fees; or (ii) Class Level Transactions may be utilised on behalf of a specific Class or Classes in accordance with the requirements of the Central Bank, in each case the Administrator shall adjust the relevant Net Asset Value per Class in order to reflect such different levels of fees payable in respect of each such Class and / or the costs and resultant gains / losses of such Class Level Transactions.
- 21.6 The Net Asset Value per Share in respect of a Class will be calculated by dividing the Net Asset Value of the relevant Class by the number of Shares of the relevant Class in issue. The Net Asset Value of a Fund attributable to a Class and the Net Asset Value per Share in respect of a Class will be expressed in the Class Currency of such Class if it is different to the Base Currency.
- 21.7 The Net Asset Value per Share with respect to a series of Shares initially will be equal to the Net Asset Value per Share of such series as of the date of its creation. The various series of Shares will be issued at different dates and accordingly the Net Asset Value per Share of one series will differ from the Net Asset Value per Share of another series. Any appreciation or depreciation of the Net Asset Value of a Fund (excluding any appreciation or depreciation resulting from expenses, income, gains and losses that are attributable to any Class Level Transaction in respect of a particular Class (as further described below)) for a Valuation Period shall be allocated among the different series of Shares pro rata in accordance with the Net Asset Value of each series at the beginning of the applicable Valuation Period, prior to any year-to-date accrued Performance Fee and excluding any Net Asset Value attributable to any Class Level Transaction in respect of a particular Class; provided, however that any such allocation to the series of a particular Class shall be subject to adjustment in the manner contemplated by the third sentence of the next paragraph. The Net Asset Value per Share (prior to any applicable Performance Fee accrual) for each series of Shares (other than any series of Shares of a Class using Class Level Transactions) is determined by attributing in each Valuation Period any appreciation or depreciation of the Net Asset Value of the Fund among the different series of Shares (as set forth above), and then dividing the Net Asset Value of such series by the number of outstanding Shares therein.
- 21.8 Class Level Transactions may be utilised for the benefit of a particular Class or group of Classes of Shares and their cost and related liabilities and/or benefits shall be for the account of such Class or group of Classes of Shares only. Accordingly, any appreciation or depreciation of the Net Asset Value of a Fund resulting from expenses, income, gains and losses that are attributable to any Class Level Transaction in respect of a particular Class or group of Classes shall be attributable solely to such Class or Classes to which it relates. Notwithstanding the prior paragraph to the contrary, the Net Asset Value for each series of a particular Class or group of Classes using Class Level Transactions (prior to any applicable Performance Fee accrual) is determined by attributing in each Valuation Period any appreciation or depreciation of the Net Asset Value of the Fund that is allocated to all series of such Class or group of Classes, as set forth above, together with any appreciation or depreciation of the Net Asset Value of the Fund resulting from expenses, income, gains and losses attributable to any Class Level Transactions utilised for the benefit of such Class or group of Classes of Shares, among the different series of such Class or group of Classes pro rata in accordance with the Net Asset Value of each series of such Class or group of Classes at the beginning of the applicable Valuation Period (which includes any Net Asset Value attributable to any Class Level Transactions in respect of such Class or group of Classes), prior to any year-to-date accrued Performance Fee. The Net Asset Value per

Share (prior to any applicable Performance Fee accrual) of each series of a Class using Class Level Transactions shall be equal to the Net Asset Value of such series divided by the number of outstanding Shares therein.

- 21.9 Shares within a series will have the same Net Asset Value per Share. The portion of the Performance Fee accrued to a particular series of Shares will then be debited against the Net Asset Value of that series.
- 21.10 The ICAV may, in each case in the sole discretion of the Directors or the AIFM on behalf of the ICAV, authorise the correction of any errors in the calculation of the Net Asset Value of a Fund or the processing of subscriptions and redemptions. Such correction may involve an adjustment to the number of Shares held by a given Shareholder(s) or the Net Asset Value at which such Shares were issued or to the redemption monies paid to such Shareholder.
- 21.11 The Directors may, in consultation with the Depositary, temporarily suspend all, any or some of the determination of the Net Asset Value, the sale, issue, valuation, purchase, allotment, conversion and / or redemption of Shares of a Fund during:
- 21.11.1 any period when any organised exchange on which a substantial portion of the investment for the time being comprised in the relevant Fund are quoted, listed, traded or dealt in is closed otherwise than for ordinary holiday, or during which dealings in any such organised exchange are restricted or suspended;
 - 21.11.2 any period where, as a result of political, military, economic or monetary events, conditions of financial markets or other circumstances beyond the control, responsibility and power of the Directors, the disposal or valuation of investments for the time being comprised in the relevant Fund cannot, in the opinion of the Directors, be effected or completed normally or without prejudicing the interest of Shareholders of that Fund;
 - 21.11.3 any breakdown in the means of communication normally employed in determining the value of any investments for the time being comprised in the relevant Fund or during any period when for any other reason the value of investments for the time being comprised in the Fund cannot, in the opinion of the Directors, be promptly or accurately ascertained;
 - 21.11.4 any period when the ICAV is unable to repatriate funds for the purposes of making redemption payments or during which the realisation of investments for the time being comprised in the Fund, or the transfer or payment of the funds involved in connection therewith cannot, in the opinion of the Directors, be effected at normal prices;
 - 21.11.5 any period when, as a result of adverse market conditions, the payment of redemption proceeds may, in the opinion of the Directors, have an adverse impact on the Fund or the remaining Shareholders in the relevant Fund;
 - 21.11.6 any period (other than ordinary holiday or customary weekend closings) when any market or exchange which is the main market or exchange for a significant part of the instruments or positions is closed, or in which trading thereon is restricted or suspended;

- 21.11.7 any period when proceeds of any sale or repurchase of the Shares cannot be transmitted to or from the account of the relevant Fund;
 - 21.11.8 any period in which the repurchase of the Shares would, in the opinion of the Directors, result in a violation of applicable laws;
 - 21.11.9 any period after a notice convening a meeting of Shareholders for the purpose of dissolving the ICAV or terminating a Fund has been issued, up to and including the date of such meeting of Shareholders;
 - 21.11.10 any period during which dealings in a collective investment scheme in which the Fund has invested a significant portion of its assets are suspended; or
 - 21.11.11 any period when the Directors determine that it is in the best interests of the Shareholders of a Fund to do so.
- 21.12 The ICAV may elect to treat the first Business Day on which the conditions giving rise to the suspension have ceased as a substitute Dealing Day in which case the Net Asset Value calculations and all issues and repurchases of Shares shall be effected on the substitute Dealing Day.
- 21.13 Any such suspension shall be published by the ICAV in such manner as it may deem appropriate to the persons likely to be affected thereby if in the opinion of the ICAV, such suspension is likely to continue for a period exceeding fourteen days and any such suspension shall be notified immediately to the Central Bank and in any event within the same Business Day.

22 Valuation of Assets

- 22.1 The Net Asset Value of the ICAV and the ICAV's assets shall be determined in accordance with requirements of the Central Bank and, subject thereto, in accordance with Schedule 2 to this Instrument. The valuation of the ICAV's assets shall be performed by the AIFM (including with the assistance of a Valuer, if any) or by an External Valuer appointed by the AIFM. The Net Asset Value per Share will be made available to Shareholders in the manner described in the Prospectus.

23 Side Pockets

- 23.1 From time to time, a portion of the ICAV's assets may consist of one or more illiquid investments (including investments that are illiquid at the time of purchase) that the Directors determine, in their sole discretion, to be subject to practical, regulatory, contractual or legal restrictions on disposition (each such investment or portfolio of investments is referred to herein as a "**Side Pocket Investment**").
- 23.2 Each Shareholder who is a Shareholder at the time a Side Pocket Investment is acquired, or at the time an existing investment or portfolio of investments is determined to be a Side Pocket Investment, may be issued shares in such Class (each a "**Side Pocket Class**") with regard to such Side Pocket Investment as the Directors may determine ("**Class S Shares**").
- 23.3 Upon identifying an investment or portfolio of investments as a Side Pocket Investment, a pro-rata portion of each existing Shareholder's shares (and, if such Shareholder holds more than one Class of shares, pro-rata according to such Shareholder's holdings of such shares)

will be converted to Class S Shares of a new Side Pocket Class by way of redemption and re-issue, without any obligation on the Shareholders or the ICAV to take any other action and without the requirement for any notice to be served on such Shareholder.

- 23.4 Shares which are redeemed and re-issued as Class S Shares may include shares in respect of which a suspension or a partial suspension of redemptions is in effect on the date on which such redemption and re-issue occurs and the entire holding of any relevant Shareholders on the Dealing Day prior to the implementation of the suspension or partial suspension of redemptions may be taken into account in calculating the pro rata portion of shares held by such Shareholder which are to be redeemed and re-issued as Class S Shares.
- 23.5 Class S Shares of a new Side Pocket Class will be issued to a Shareholder in a Base Currency amount equal to (i) the aggregate value of such Shareholder's shares divided by the aggregate value of all of the issued and outstanding shares (excluding for this purpose, any Class S Shares then outstanding and in the event that a suspension or a partial suspension of redemption is in effect on the date of such issue, calculated based on the shares in issue on the last Dealing Day on which no suspension or partial suspension of redemptions was in effect) multiplied by (ii) the book value of the Side Pocket Investment attributable to the relevant Class S Shares.
- 23.6 Members who purchase shares after a Fund acquires a Side Pocket Investment are not entitled to receive any Class S Shares with respect to such Side Pocket Investment or to participate in the gain, loss or income relating to such Class S Shares. For the purpose of determining the number of Class S Shares in a Side Pocket Class to be issued to each Member, the initial Net Asset Value per Class S Share of such Side Pocket Class shall be such amount as the Directors may determine. Class S Shares may also be designated in the Class Currency of any shares which were redeemed in conjunction with the issue of such Class S Shares.

24 **General Meetings**

- 24.1 All general meetings of the ICAV shall be held in Ireland and attendance in person shall be, as determined by the Directors, either physical or via suitable electronic conferencing means.
- 24.2 Subject to Section 24.3, the ICAV shall in each year hold a general meeting as its annual general meeting in addition to any other meeting in that year. Not more than fifteen months shall elapse between the date of one annual general meeting of the ICAV and that of the next **PROVIDED THAT** so long as the ICAV holds its first annual general meeting within eighteen months after the date on which the registration order made by the Central Bank in respect of the ICAV comes into operation it need not hold it in the year of its incorporation or in the following year.
- 24.3 The Directors may elect to dispense with the holding of an annual general meeting by giving sixty (60) days' written notice to all Shareholders. Any such election has effect for the year in which it is made and subsequent years, but does not affect any liability already incurred by reason of default in holding an annual general meeting. Where an election under this Section 24.3 has effect for a year, one or more Shareholders of the ICAV holding, or together holding, not less than 10% of the voting rights in the ICAV or the auditors of the ICAV may require the ICAV to hold an annual general meeting in that year by giving notice in writing to the ICAV in the previous year or at least one month before the end of that year and the ICAV shall hold the required meeting.

24.4 All general meetings (other than annual general meetings) shall be called extraordinary general meetings.

24.5 The Directors may call an extraordinary general meeting whenever they think fit and extraordinary general meetings shall be convened on such requisition, or in default may be convened by such requisitionists, and in such manner as provided by the Act.

25 **Notice of General Meetings**

25.1 At least twenty-one clear days' notice specifying the place, the day and the hour of the meeting, and in the case of special business the general nature of such business (and in the case of an annual general meeting specifying the meeting as such) shall be given in the manner hereinafter mentioned to such persons as are under the provisions hereof or the conditions of issue of the Shares held by them entitled to receive notices from the ICAV.

25.2 The Directors, the AIFM, the Investment Manager, the Depositary, the Administrator and the Auditors shall each be entitled to receive notice of, and attend and speak at, any general meeting of the ICAV.

25.3 In each notice calling a meeting of the ICAV, there shall appear with reasonable prominence a statement that a Shareholder entitled to attend and vote is entitled to appoint one or more proxies to attend and vote instead of him/her and that a proxy need not also be a Shareholder.

25.4 The accidental omission to give notice to, or the non-receipt of notice by, any person entitled to receive notice shall not invalidate the proceedings at any general meeting.

26 **Proceedings at General Meetings**

26.1 All business shall be deemed special that is transacted at an extraordinary general meeting and also all business that is transacted at an annual general meeting, with the exception of the consideration of the accounts and the reports of the Directors and Auditors, the election of Directors in the place of those retiring, the reappointment of the retiring Auditors and the fixing of the remuneration of the Auditors.

26.2 No business shall be transacted at any general meeting unless a quorum is present. Two Shareholders holding voting Shares present either in person or by proxy shall be a quorum for a general meeting. A representative of a corporation authorised pursuant to Section 27.12 to be present at any meeting of the ICAV shall be deemed to be a Shareholder for the purpose of a quorum.

26.3 If within half an hour from the time appointed for a meeting a quorum is not present, the meeting, if convened on the requisition of or by Shareholders, shall be dissolved. In any other case it shall stand adjourned to the same day in the next week, at the same time and place or to such other day and at such other time and place as the Directors may determine. One Shareholder (including, for the avoidance of doubt a Subscriber Shareholder) present either in person or by proxy shall be a quorum for any such adjourned meeting.

26.4 The chairperson or, if absent, the deputy chairperson of the ICAV, or failing him/her, some other Director nominated by the Directors shall preside as chairperson at every general meeting of the ICAV, but if at any meeting neither the chairperson nor the deputy chairperson nor such other Director be present within fifteen minutes after the time appointed for holding

the meeting, or if none of them be willing to act as chairperson, the Directors present shall choose some Director present to be chairperson, or if no Directors be present, or if all the Directors present decline to take the chair, the Shareholders present shall choose some Shareholder present to be chairperson.

- 26.5 The chairperson may with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting) adjourn the meeting from time to time and from place to place but no business shall be transacted at any adjourned meeting except business which might lawfully have been transacted at the meeting from which the adjournment took place. When a meeting is adjourned for fourteen days or more ten days' notice at the least specifying the place, the day and the hour of the adjourned meeting, shall be given as in the case of the original meeting but it shall not be necessary to specify in such notice the nature of the business to be transacted at the adjourned meeting. Save as aforesaid, it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.
- 26.6 At any general meeting, a resolution put to the vote of the meeting shall be decided on a show of hands of those Shareholders holding voting Shares, unless a resolution is not passed unanimously on such show of hands, in which case such resolution shall be decided on a poll. Unless a poll is so taken, a declaration by the chairperson that a resolution has been carried, or carried unanimously, or by a particular majority, or lost, or not carried by a particular majority, and an entry to that effect in the book containing the minutes of the proceedings of the ICAV shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution.
- 26.7 If a poll is duly demanded, it shall be taken in such manner and at such place as the chairperson may direct (including the use of ballot or voting papers or tickets) and the result of a poll shall be deemed to be the resolution of the meeting at which the poll was demanded.
- 26.8 The chairperson may, in the event of a poll, appoint scrutineers and may adjourn the meeting to some place and time fixed by him/her for the purpose of declaring the result of the poll.
- 26.9 In the case of an equality of votes, whether on a show of hands or on a poll, the chairperson of the meeting at which the show of hands takes place or at which the poll is demanded shall be entitled to a second or casting vote.
- 26.10 A poll demanded on the election of a chairperson and a poll demanded on a question of adjournment shall be taken forthwith. A poll demanded on any other question shall be taken at such time and place as the chairperson directs not being more than thirty days from the date of the meeting or adjourned meeting at which the poll was demanded.
- 26.11 The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll has been demanded.
- 26.12 A demand for a poll may be withdrawn and no notice need be given of a poll not taken immediately.
- 26.13 If at any time the share capital is divided into different Classes of Shares, the rights attached to any Class (unless otherwise provided by the terms of issue of the Shares of that Class or unless otherwise provided herein) may, whether or not the ICAV is being wound up, be varied with the consent in writing of the holders of three-fourths of the issued Shares of that Class, or with the sanction of an Extraordinary Resolution passed at a separate general meeting of

the holders of the Shares of that Class, to which the provisions of this Instrument relating to general meetings shall apply *mutatis mutandis*, save that the quorum at any such general meeting shall be two or more Shareholders present in person or by proxy together holding at least one-third of the Shares of the relevant Class.

27 **Votes of Shareholders**

- 27.1 Subject to any special rights or restrictions for the time being attached to any Class of Shares in accordance with the requirements of the Central Bank, each Shareholder shall be entitled to such number of votes as shall be produced by dividing the aggregate net asset value of that Shareholder's Shareholding (expressed or converted in Base Currency, calculated as of the relevant record date and excluding, where appropriate, the impact of any Class Currency hedging) by one. Where a separate written resolution or general meeting of a particular Class of Shares is held, in such circumstances, the Shareholder's votes shall be calculated by reference only to the net asset value of each Shareholder's Shareholding in that particular Class, as appropriate. The Subscriber Shareholders shall have one (1) vote for each Subscriber Share held. The "*relevant record date*" for these purposes shall be a date being not more than thirty (30) days prior to the date of the relevant general meeting or written resolution as determined by the Directors. In relation to a resolution which in the opinion of the Directors affects more than one (1) Class of Shares, such resolution shall be deemed to have been duly passed only if, in lieu of being passed through a single meeting of the Shareholders of such Class of Shares, such resolution shall have been passed at a separate meeting of the Shareholders of each such Classes. The Directors may in their discretion create Classes which shall be designated as non-voting Shares and the holders of such Shares will not have the right to vote at any meeting of the ICAV.
- 27.2 In the case of joint holders of a Share, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders, and for this purpose seniority shall be determined by the order in which the names stand in the Register in respect of the Shares.
- 27.3 No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is given or tendered, and every vote not disallowed at such meeting shall be valid for all purposes. Any such objection made in due time shall be referred to the chairperson of the meeting, whose decision shall be final and conclusive.
- 27.4 On a poll votes may be given either personally or by proxy.
- 27.5 On a poll, a Shareholder entitled to more than one vote need not, if he/she votes, use all his/her votes or cast all the votes he/she uses in the same way.
- 27.6 The instrument appointing a proxy shall be in writing under the hand of the appointer or of his/her attorney duly authorised in writing, or if the appointer is a corporation, either under its common seal or under the hand of an officer or attorney so authorised. An instrument of proxy shall be in any usual form or in such form as the Directors may approve PROVIDED ALWAYS that such form shall give the holder the choice of authorising his / her proxy to vote for or against each resolution.
- 27.7 Any person (whether a Shareholder or not) may be appointed to act as a proxy. A Shareholder may appoint more than one proxy to attend on the same occasion.

- 27.8 The instrument appointing a proxy and the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power or authority, shall be deposited at the registered office of the ICAV or at such other place as is specified for that purpose in the notice of meeting or in the instrument of proxy issued by the ICAV not less than forty-eight hours (or such other time as the Directors may determine at their discretion) before the time appointed for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote and if the aforesaid conditions are not complied with the instrument of proxy shall not be treated as valid.
- 27.9 No instrument appointing a proxy shall be valid after the expiration of twelve months from the date named in it as the date of its execution, except at an adjourned meeting or on a poll demanded at a meeting or an adjourned meeting in cases where the meeting was originally held within twelve months from such date.
- 27.10 The Directors may at the expense of the ICAV send, by post or otherwise, to the Shareholders instruments of proxy (with or without prepaid postage for their return) for use at any general meeting or at any meeting of any Class of Shareholders, either in blank or nominating in the alternative any one or more of the Directors or any other persons. If for the purpose of any meeting invitations to appoint as proxy a person or one of a number of persons specified in the invitations are issued at the expense of the ICAV, such invitations shall be issued to all (and not to some only) of the Shareholders entitled to be sent a notice of the meeting and to vote thereat by proxy.
- 27.11 A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the death or insanity of the principal or the revocation of the instrument of proxy, or of the authority under which the instrument of proxy was executed, or the transfer of the Shares in respect of which the instrument of proxy is given, provided that no notice in writing of such death, insanity, revocation or transfer shall have been received by the ICAV at the registered office of the ICAV, before the commencement of the meeting or adjourned meeting at which the instrument of proxy is used.
- 27.12 Any body corporate which is a Shareholder may authorise by resolution of its Directors or other governing body such person as it thinks fit to act as its representative at any meeting of the ICAV and the person so authorised shall be entitled to exercise the same powers on behalf of the body corporate which he/she represents as that body corporate could exercise if it were an individual Shareholder and such body corporate shall for the purposes of these presents be deemed to be present in person at any such meeting if a person so authorised is present thereat.
- 27.13 A resolution in writing signed by all of the Shareholders for the time being entitled to attend and vote on such resolution at a general meeting (or being bodies corporate by their duly authorised representative) shall be as valid and effective for all purposes as if the resolution had been passed at a general meeting of the ICAV duly convened and held, and may consist of several documents in like form each signed by one or more persons, and if described as a Special Resolution shall be deemed to be a Special Resolution within the meaning of the Act. Any such resolution shall be served on the ICAV.
- 27.14 The provisions of Sections 24, 25, 26 and 27 shall apply *mutatis mutandis* to meetings of each Class of Shareholders.

28 **Directors**

- 28.1 Unless otherwise determined by the ICAV by Ordinary Resolution, the number of the Directors shall not be less than two nor more than twelve.
- 28.2 A Director need not be a Shareholder.
- 28.3 The Directors shall have power at any time and from time to time to appoint any person to be a Director, either to fill a casual vacancy or as an addition to the existing Directors, but subject to the requirements of the Central Bank.
- 28.4 The Directors shall be entitled to such remuneration in relation to the performance of their duties as the Directors may from time to time determine. The aggregate remuneration of the Directors shall not exceed €150,000 per annum (or such other sum as the Directors may from time to time determine and disclose to the Shareholders). Such remuneration shall be deemed to accrue from day to day. The Directors and any alternate Directors may also be paid all travelling, hotel and other expenses properly incurred by them in attending and returning from meetings of the Directors or any committee of the Directors or general meetings or any meetings in connection with the business of the ICAV.
- 28.5 The Directors may in addition to such remuneration as is referred to in Section 28.4 hereof grant special remuneration to any Director who, being called upon, shall perform any special or extra services to or at the request of the ICAV.
- 28.6 The office of a Director shall be vacated by a Director in any of the following events, namely:
- 28.6.1 if he/she resigns his office by notice in writing signed by him/her and left at the registered office of the ICAV;
 - 28.6.2 if he/she becomes bankrupt or makes any arrangement or composition with his/her creditors generally;
 - 28.6.3 if he/she becomes of unsound mind;
 - 28.6.4 if he/she ceases to be a Director by virtue of, or becomes prohibited from being a Director by reason of, an order made under the provisions of any law or enactment;
 - 28.6.5 if he/she is requested by a majority of the other Directors (not being less than two in number) to vacate office;
 - 28.6.6 if he/she is removed from office by an Ordinary Resolution, in accordance with section 62 of the Act.
- 28.7 At a general meeting, a motion for the appointment of two or more persons as Directors of the ICAV by a single resolution shall not be made, unless a resolution that it shall be so made has been first agreed to by the meeting without any vote being given against it.
- 28.8 Subject to the requirements of the Central Bank, any Director may at any time by instrument in writing under his/her hand and deposited at the registered office, or delivered at a meeting of the Directors, appoint any Director or other person to be his/her alternate Director and may in like manner at any time terminate such appointment.

- 28.9 The appointment of an alternate Director shall determine if his/her appointer ceases to be a Director or on the happening of any such event which if he/she were a Director would cause him/her to vacate such office.
- 28.10 An alternate Director shall be entitled to receive notices of meetings of the Directors and shall be entitled to attend and vote as a Director at any such meeting at which the Director appointing him/her is not personally present and generally at such meeting to perform all functions of his/her appointer as a Director and for the purposes of the proceedings at such meeting the provisions hereof shall apply as if he/she (instead of his/her appointer) were a Director. If he/she himself/herself shall be a director, or shall attend any such meeting as an alternate for more than one Director, his/her voting rights shall be cumulative, provided, however, that he/she shall count as one for the purposes of determining a quorum. If his/her appointer is for the time being temporarily unable to act, his/her signature to any resolution in writing of the Directors shall be as effective as the signature of his/her appointer. To such extent as the Directors may from time to time determine in relation to any committee of the Directors, the foregoing provisions of this paragraph shall also apply *mutatis mutandis* to any meeting of any such committee of which his/her appointer is a Shareholder. An alternate Director shall not (save as aforesaid or as otherwise herein provided) have power to act as a Director nor shall he/she be deemed to be a Director.
- 28.11 An alternate Director shall be entitled to contract and be interested in and benefit from contracts or arrangements or transactions and to be repaid expenses and to be indemnified to the same extent *mutatis mutandis* as if he/she were a Director but he/she shall not be entitled to receive from the ICAV in respect of his/her appointment as alternate Director any remuneration except only such part (if any) of the remuneration otherwise payable to his/her appointer as such appointer may by notice in writing to the ICAV from time to time direct.

29 **Directors, Offices and Interests**

- 29.1 The Directors may appoint one or more of their body to the office of managing Director or joint managing Director or to any other executive office under the ICAV (including, where considered appropriate, the office of chairperson) on such terms and for such period as they may determine and, without prejudice to the terms of any contract entered into in any particular case, may revoke any such appointment at any time.
- 29.2 A Director holding any such executive office shall receive such remuneration, whether in addition to, or in substitution for, his/her ordinary remuneration, as a Director and whether by way of salary, commission, participation in profits or otherwise or partly in one way and partly in another, as the Directors may determine.
- 29.3 The appointment of any Director to the office of chairperson or managing or joint managing Director shall determine automatically if he/she ceases to be a Director but without prejudice to any claim for damages for breach of any contract of service between him/her and the ICAV.
- 29.4 The appointment of any Director to any other executive office shall not determine automatically if he/she ceases from any cause to be a Director unless the contract or resolution under which he/she holds office shall expressly state otherwise, in which event such determination shall be without prejudice to any claim for damages for breach of any contract of service between him/her and the ICAV.

- 29.5 A Director may hold any other office or place of profit under the ICAV (except that of Auditor) in conjunction with his/her office of Director, and may act in a professional capacity to the ICAV, on such terms as to remuneration and otherwise as the Directors may arrange.
- 29.6 Subject to the provisions of the Act, and provided that he/she has disclosed to the Directors the nature and extent of any material interest of his/her , a Director notwithstanding his/her office:
- 29.6.1 may be a party to, or otherwise interested in, any transaction or arrangement with the ICAV or in which the ICAV is interested; and
- 29.6.2 shall not be accountable, by reason of his/her office, to the ICAV for any benefit which he/she derives from any such office or employment or from any such transaction or arrangement or from any interest in any such body corporate and no such transaction or arrangement shall be liable to be avoided on the ground of any such interest or benefit.
- 29.7 No Director or intending Director shall be disqualified by his/her office from contracting with the ICAV either as vendor, purchaser or otherwise, nor shall any such contract or any contract or arrangement entered into by or on behalf of the other company in which any Director shall be in any way interested be avoided nor shall any Director so contracting or being so interested be liable to account to the ICAV for any profit realised by any such contract or arrangement by reason of such Director holding that office or of the fiduciary relationship thereby established. The nature of a Director's interest must be declared by him/her at the meeting of the Directors at which the question of entering into the contract or arrangement is first taken into consideration, or if the Director was not at the date of that meeting interested in the proposed contract or arrangement at the next meeting of the Directors held after he/she became so interested, and in a case where the Director becomes interested in a contract or arrangement after it is made, at the first meeting of the Directors held after he/she becomes so interested.
- 29.8 A copy of every declaration made and notice given in relation to a Director's Shares shall be entered in a book kept for this purpose. Such book shall be open for inspection during normal business hours without charge by any Director, Secretary, Auditor or Shareholder at the registered office of the ICAV and shall be produced at every general meeting of the ICAV and at any meeting of the Directors if any Director so requests in sufficient time to enable the book to be available at the meeting by any Shareholder or holder of debentures of the ICAV.
- 29.9 For the purposes of this section:
- 29.9.1 a general notice given to the Directors that a Director is to be regarded as having an interest of the nature and extent specified in the notice in any transaction or arrangement in which a specified person or class of persons is interested shall be deemed to be a disclosure that the Director has an interest in any such transaction of the nature and extent so specified;
- 29.9.2 an interest of which a Director has no knowledge and of which it is unreasonable to expect him/her to have knowledge shall not be treated as an interest of his/her ;
- 29.9.3 an interest of a person who is the spouse or a minor child of a Director shall be treated as an interest of the Director and, in relation to an alternate Director, an

interest of his/her appointer shall be treated as an interest of the alternate Director.

- 29.10 Save as otherwise provided by this Instrument, a Director shall not vote at a meeting of the Directors or a committee of Directors on any resolution concerning a matter in which he/she has, directly or indirectly, an interest which is material or a duty which conflicts or may conflict with the interests of the ICAV. Unless otherwise resolved by the Directors, a Director shall not be counted in the quorum present at a meeting in relation to any such resolution on which he/she is not entitled to vote.
- 29.11 A Director shall be entitled (in the absence of some other material interest than is indicated below) to vote (and be counted in the quorum) in respect of any resolution concerning any of the following matters, namely any proposal concerning any other company in which he/she is interested, directly or indirectly, and whether as an officer or Shareholder or otherwise howsoever.
- 29.12 Where proposals are under consideration concerning the appointment (including fixing or varying the terms of appointment) of two or more Directors to offices or employments with the ICAV such proposals may be divided and considered in relation to each Director separately and in such case each of the Directors concerned (if not otherwise debarred from voting) shall be entitled to vote (and be counted in the quorum) in respect of each resolution, except that concerning his/her own appointment.
- 29.13 If a question arises at a meeting of Directors or of a committee of Directors as to the materiality of a Director's interest or as to the right of any Director to vote and such question is not resolved by his/her voluntarily agreeing to abstain from voting, such question may be referred, before the conclusion of the meeting, to the chairperson of the meeting and his/her ruling in relation to any Director other than himself/herself shall be final and conclusive.
- 29.14 The ICAV, by Ordinary Resolution, may suspend or relax the provisions of this section to any extent or ratify any transaction not duly authorised by reason of a contravention of this section.

30 Powers of Directors

- 30.1 The business of the ICAV shall be managed by the Directors, who may exercise all such powers of the ICAV as are not by the Act, by the AIFM Rules or hereby required to be exercised by the ICAV in general meeting, subject, nevertheless, to the provisions of the Act, to the AIFM Rules and to the regulations herein contained being not inconsistent with the aforesaid regulations as may be prescribed by the ICAV in general meeting, but no regulations made by the ICAV in general meeting shall invalidate any prior act of the Directors which would have been valid if such regulations had not been made. The general powers given by this Section shall not be limited or restricted by any special authority or power given to the Directors by this or any other Section.
- 30.2 The Directors, on behalf of the ICAV may subject to the AIFM Rules, form one or more Subsidiaries. All of the shares of a Subsidiary established in corporate form shall be held by the Depositary or its nominee or otherwise in accordance with the requirements of the Central Bank for the ICAV with the intention that transactions (including, without limitation, futures and options transactions) should be carried out by the Subsidiary, with all assets being held by the Depositary or its nominee for the account of a Subsidiary or otherwise as the Central

Bank may permit. The investment and borrowing restrictions will take effect as if all the assets of, and all the liabilities of, any Subsidiary were held or owned directly by the ICAV.

30.3 All cheques, promissory notes, drafts, bills of exchange and other negotiable or transferable instruments drawn on the ICAV, and all other receipts for moneys paid to the ICAV shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, in such manner as the Directors from time to time shall by resolution determine.

30.4 Subject to the AIF Rulebook, the Directors may exercise all the powers of the ICAV to invest all or any funds of the ICAV as authorised by this Instrument. Subject to the provisions of the AIF Rulebook and with the authorisation of the Central Bank, the ICAV may invest in collective investment undertakings with which the ICAV is linked by common management and control or by substantial direct or indirect holding, provided that the said collective investment undertaking has investment policies consistent with the investment policies of the ICAV. No such investment may be made unless the manager of the relevant collective investment undertaking has agreed to waive any preliminary or initial charge which it might otherwise be entitled to charge for its own benefit in respect of such investment.

31 **Borrowing and Hedging Powers**

Subject to the limits and conditions set forth in the Prospectus and laid down by the Central Bank and subject to the provisions of Section 30 hereof, the Directors may, with the prior approval of the Investor Advisory Committee, exercise all the powers of the ICAV to borrow money, to mortgage or charge its undertaking, property, or any part thereof and to issue debentures, debenture stock and other securities whether outright or as a security for any debts and to use techniques and instruments for hedging and investment purposes.

32 **Proceedings of Directors**

32.1 The Directors may meet together for the dispatch of business, adjourn and otherwise regulate their meetings as they think fit. Questions arising at any meeting shall be determined by a majority of votes. In case of an equality of votes, the chairperson shall have a second or casting vote. A Director may, and the Secretary on the requisition of a Director shall, at any time summon a meeting of the Directors.

32.2 The quorum necessary for the transaction of business of the Directors may be fixed by the Directors, and unless so fixed at any other number shall be two.

32.3 The continuing Directors or a sole continuing Director may act notwithstanding any vacancies in their number but, if and so long as the number of Directors is reduced below the minimum number fixed by or in accordance with the provisions hereof or a majority or quorum of Directors cannot be attained, the continuing Directors or Director may act for the purpose of filling vacancies in their number or of summoning general meetings of the ICAV, but not for any other purpose. If there be no Directors or Director able or willing to act, then any two Shareholders may summon a general meeting for the purpose of appointing Directors.

32.4 The Directors may from time to time elect or remove a chairperson and, if they think fit, a deputy chairperson and determine the period for which they respectively are to hold office.

32.5 The chairperson or, failing him/her, the deputy chairperson shall preside at all meetings of the Directors, but if there be no chairperson or deputy chairperson, or if at any meeting the chairperson or deputy chairperson be not present within five minutes after the time appointed

for holding the same, the Directors present may choose one of their number to be chairperson of the meeting.

- 32.6 A resolution in writing signed by all the Directors for the time being entitled to receive notice of a meeting of the Directors and to vote thereat shall be as valid and effectual as a resolution passed at a meeting of the Directors duly convened and may consist of several documents in the like form each signed by one or more of the Directors. A resolution in writing shall be deemed to have been signed in the country or place where the last signatory to sign the resolution in writing executes such resolution.
- 32.7 A meeting of the Directors for the time being at which a quorum is present shall be competent to exercise all powers and discretions for the time being exercisable by the Directors.
- 32.8 The Directors may delegate any of their powers to committees consisting of such of their Shareholders as they think fit. The meetings and proceedings of any such committee shall conform to the requirements as to quorum imposed under the provisions of Section 32.2 and shall be governed by the provisions hereof regulating the meetings and proceedings of the Directors so far as the same are applicable and are not superseded by any regulations imposed on them by the Directors.
- 32.9 The Directors may, whether by standing resolution or otherwise, delegate their powers relating to the issue and repurchase of Shares and the calculation of the Net Asset Value of the Shares, the declaration of dividends and all management and administrative duties in relation to the ICAV, to the Administrator or to any duly authorised Officer or other person, subject to such terms and conditions as the Directors in their absolute discretion may resolve.
- 32.10 The Directors may delegate their powers relating to the management of the ICAV's assets to the AIFM or the Investment Manager or to any duly authorised Officer or other person, subject to such terms and conditions as the Directors in their absolute discretion may resolve.
- 32.11 All acts done by any meeting of Directors, or of a committee of Directors or by any person authorised by the Directors shall, notwithstanding it be afterwards discovered that there was some defect in the appointment or authorisation of any such Directors or person acting as aforesaid, or that they or any of them were disqualified, or had vacated office, or were not entitled to vote, be as valid as if every such person had been duly appointed, and was qualified and had continued to be a Director and had been entitled to vote.
- 32.12 The Directors shall as soon as may be cause minutes to be made of:
- 32.12.1 all appointments of officers made by the Directors;
 - 32.12.2 the names of the Directors present at each meeting of the Directors and of any committee of Directors; and
 - 32.12.3 all resolutions and proceedings of all general meetings of the ICAV and of the Directors and of committees of Directors;
- and such minutes shall be entered in books kept for that purpose.
- 32.13 Any such minutes as are referred to in Section 32.12 hereof, if purporting to be signed by the chairperson of the meeting at which the proceedings took place, or by the chairperson of the

next succeeding meeting, shall, until the contrary be proved, be conclusive evidence of their proceedings.

- 32.14 Any Director may participate in a meeting of the Directors or any committee of the Directors by means of a conference telephone or other telecommunication equipment by means of which all persons participating in the meeting can hear each other speak and such participation in a meeting shall constitute presence in person at the meeting and such meeting shall be deemed to have been convened (a) in the place from which the conference telephone call or similar telecommunication is initiated or (b) in the location of the chairperson, provided always that the quorum must be constituted in accordance with Section 32.2.

33 **Secretary**

The Secretary shall be appointed by the Directors. The Secretary shall be appointed by the Directors for such term, at such remuneration and on such conditions as they may think fit; and any Secretary so appointed may be removed by them. Anything required or authorised to be done by the Secretary may, if the office is vacant or there is for any other reason no Secretary capable of acting, be done by any assistant or deputy Secretary or if there is no assistant or deputy Secretary capable of acting, by any officer of the ICAV authorised generally or specially in that behalf by the Directors **PROVIDED THAT** any provisions hereof requiring or authorising anything to be done by a Director and the Secretary shall not be satisfied by its being done by the same person acting both as Director and as, or in the place of, the Secretary. Any reference to a Secretary in this Section 33 may be deemed to include a reference to joint secretaries where joint secretaries are so appointed.

34 **Execution of Documents**

- 34.1 The ICAV shall not have a common seal.

- 34.2 Any document expressed to be executed by the ICAV and signed on behalf of the ICAV:

34.2.1 by two authorised signatories of the ICAV; or

34.2.2 by a Director in the presence of a witness who attests the signature;

shall have the same effect as if executed under the common seal of the ICAV.

- 34.3 The term "*authorised signatories*" as used in this Section shall mean:

34.3.1 a Director;

34.3.2 the Secretary or any joint secretary of the ICAV.

35 **Dividends**

- 35.1 The Directors may from time to time as they think fit pay such dividends on any Class of Shares of the ICAV as appear to the Directors to be justified, subject to any policy statement in relation to dividends in the Prospectus.

- 35.2 Unless otherwise provided for in the Prospectus, the aggregate amount available for distribution by way of dividend in any Accounting Period in respect of a Class of Shares shall

be a sum equal to the aggregate of the ICAV's share capital, accumulated reserves, net realised and net unrealised capital gains and losses and the net income received by the ICAV (whether in the form of dividends, interest or otherwise) during the Accounting Period.

- 35.3 The Directors may, with the sanction of an Ordinary Resolution, distribute in kind among Shareholders by way of dividend or otherwise any of the assets of the ICAV (other than any assets which have a contingent liability).
- 35.4 Shares shall qualify for dividend in such manner as may be determined by the Directors or as may be set out in the Prospectus relating to such Shares.
- 35.5 Any declaration of a dividend by the Directors may specify that the same shall be payable to the persons registered as the Shareholders at the close of business on a particular date, and thereupon the dividend shall be payable to them in accordance with their respective holdings so registered, but without prejudice to the rights *inter se* in respect of such dividend, of transferors and transferees of Shares.
- 35.6 The ICAV may transmit any dividend or other amount payable in respect of any Share by cheque or warrant sent by ordinary post to the registered address of the Shareholder, or, in the case of joint holders, to the person whose name and address appears first on the Register and shall not be responsible for any loss arising in respect of such transmission.
- 35.7 No dividend or other amount payable to any holder of Shares shall bear interest against the ICAV. All unclaimed dividends and other amounts payable as aforesaid may be invested or otherwise made use of for the benefit of the ICAV until claimed. Payment by the ICAV of any unclaimed dividend or other amount payable in respect of a Share into a separate account shall not constitute the ICAV a trustee in respect thereof. Any dividend unclaimed after six years from the date when it first became payable shall be forfeited automatically, without the necessity for any declaration or other action by the relevant Fund.
- 35.8 At the option of any Shareholder, the Directors may apply all dividends declared on a Class of Shares held by such Shareholder in the issue of additional Shares in that Class in the ICAV to that Shareholder at the Net Asset Value obtaining when such dividends are declared and on such terms as the Directors from time to time may resolve, provided, however, that any Shareholder shall be entitled to elect to receive a cash dividend in respect of the Shares held by that Shareholder.
- 35.9 The Directors may provide that Shareholders will be entitled to elect to receive in lieu of any dividend (or part thereof) in respect of any Shares an issue of additional Shares in that Class credited as fully paid. In any such case the following provisions shall apply:
- 35.9.1 the number of additional Shares (including any fractional entitlement) to be issued in lieu of any amount of dividend shall be equal in value to the amount of such dividend at the date the dividend was declared;
- 35.9.2 the dividend (or that part of the dividend in respect of which a right of election has been accorded) shall not be payable on Shares in respect of which the Share election has been duly exercised (the "**Elected Shares**"), and in lieu thereof additional Shares shall be issued to the holders of the Elected Shares on the basis determined as aforesaid and for such purpose the Directors shall capitalise a sum equal to the aggregate value of the dividends in respect of which elections

have been made and apply the same in paying up in full the appropriate amount of unissued Shares;

35.9.3 the additional Shares so issued shall rank *pari passu* in all respects with the fully-paid Shares then in issue save only as regards participation in the relevant dividend (or Share election in lieu);

35.9.4 the Directors may do all acts and things considered necessary or expedient to give effect to any such capitalisation, with full power to the Directors to make such provision as they think fit in the case of Shares becoming distributable in fractions so that, fractional entitlements are disregarded or rounded up or the benefit of fractional entitlements accrues to the ICAV or the ICAV issues Fractional Shares; and

35.9.5 the Directors may on any occasion determine that rights of election shall not be made available to any Shareholder with registered addresses in any territory where in the absence of a registration statement or other special formalities the circulation of an offer of rights of election would or might be unlawful, and in such event the provisions aforesaid shall be read and construed subject to such determination.

35.10 Where the ICAV proposes to pay a distribution to a Shareholder, it shall be entitled to deduct from the distribution such amount that may be necessary to discharge the ICAV's liability to taxation in respect of such distribution and the ICAV shall arrange to discharge the amount of taxation due.

36 **Untraced Shareholders**

36.1 The ICAV shall be entitled to repurchase any Share of a Shareholder or any Share to which a person is entitled by transmission and to forfeit any dividend which is declared and remains unpaid for a period of six years.

36.2 The ICAV shall account to the Shareholder or to the person entitled to such Share for the net proceeds of such repurchase by carrying all moneys in respect thereof to a separate interest bearing account which shall be a permanent debt of the ICAV and the ICAV shall be deemed to be a debtor and not a trustee in respect thereof for such Shareholder or other person.

37 **Accounts**

37.1 The Directors shall cause to be kept books of account as are necessary in relation to the conduct of its business or as are required by the Act and the AIFM Rules so as to enable the accounts of the ICAV to be prepared.

37.2 The books of account shall be kept at the registered office, or at such other place or places as the Directors shall think fit in accordance with the Act, and shall at all reasonable times be open to for inspection without charge by the Officers of the ICAV and by other persons entitled pursuant to the Act to inspect the accounting records of the ICAV. However, other than the aforesaid, no other person shall be entitled to inspect the books, accounts, documents or writings of the ICAV, except as authorised by the Directors or by the ICAV in general meeting.

- 37.3 A balance sheet, including every document required by law to be annexed to it, and a profit and loss account of the ICAV, shall be made out as at the end of each Accounting Period of the ICAV and shall be audited by the Auditors and laid before the ICAV at its annual general meeting in each year (if any), and such balance sheet shall contain a general summary of the assets and liabilities of the ICAV and all information required to be included by the Act. The balance sheet shall be accompanied by a report of the Directors as to the state and condition of the ICAV, the amount (if any) which they recommend should be paid by way of dividend, the amount (if any) which they have carried or propose to carry to reserve, and shall include such information as is required pursuant to the Act, together with a profit and loss account. The balance sheet of the ICAV and the report of the Directors and the profit and loss account shall be signed on behalf of the Directors by at least two of the Directors. An Auditors' report shall be attached to the balance sheet of the ICAV. The Auditors' report shall be read at the annual general meeting (if any).
- 37.4 Once at least in every year the Directors shall cause to be prepared an Annual Report relating to the management of the ICAV during the relevant Accounting Period. The Annual Report shall include the balance sheet and profit and loss account duly audited by the Auditors and the Directors' Report and the Auditors' Report as provided for in Section 37.3 and shall be in a form approved by the Central Bank and shall contain such information as required by the Act and the AIFM Regulations and as specified by the Central Bank. There shall be attached to such Annual Report such additional information and reports as the Central Bank may specify.
- 37.5 A copy of the Annual Report including the balance sheet (including every document required by law to be annexed thereto) together with a copy of the Directors' report and the Auditors' report shall be made available by the ICAV to every person entitled under the Act and the AIFM Rules to receive them and if any of the Shares are quoted on any stock exchange, the required number of copies of these documents shall be forwarded at the same time to such stock exchange.
- 37.6 In accordance with Irish law and regulations, the Directors may elect to prepare the Annual Report and accounts in accordance with generally accepted accounting practice in Ireland or in accordance with such international accounting standards or such alternative body of accounting standards as may be permitted under the Act and the AIFM Regulations from time to time.
- 37.7 The Auditors' certificate appended to the Annual Report and statement referred to herein shall declare that the accounts or statement attached respectively thereto (as the case may be) have been examined together with the books and records of the ICAV and of the Administrator in relation thereto, that the information given in the Annual Report relating to the Accounting Period concerned is consistent with the accounts and that the Auditors have obtained all the information and explanations they have required and the Auditors shall report whether the accounts are in their opinion properly drawn up in accordance with such books and records and present a true and fair view of the state of affairs of the ICAV, and whether the accounts are in their opinion properly drawn up in accordance with the provisions hereof.
- 37.8 If it appears to the Directors that any Annual Report of the ICAV did not comply with the requirements of the Act or the AIFM Rules, the Directors may prepare a revised Annual Report.

37.9 The Directors of the ICAV may elect to prepare separate accounts in respect of a Fund or Funds and if the Directors elect to do so, all relevant provisions of this section relating to the accounts of the ICAV shall be read as referring to the Fund or Funds in respect of which the separate accounts are to be prepared.

38 **Audit**

38.1 The appointment, resignation and removal of Auditors and the determination of eligibility for appointment as Auditors to the ICAV shall be governed by the provisions of the Act.

38.2 Subject to Section 38.5, the ICAV shall at an annual general meeting appoint an Auditor or Auditors to hold office from the conclusion of that meeting until the conclusion of the next annual general meeting, in accordance with the provisions of the Act.

38.3 A person, other than a retiring Auditor, shall not be capable of being appointed Auditor at an annual general meeting unless notice of an intention to nominate that person to the office of Auditor has been given by a Shareholder to the ICAV not less than twenty eight clear days before the annual general meeting and the Directors shall send a copy of any such notice to the retiring Auditor and shall give notice thereof to the Shareholders in accordance with the Act.

38.4 The first Auditors shall be appointed by the Directors at any time before the first annual general meeting, and they shall hold office until the conclusion of the first annual general meeting unless previously removed by a resolution of the ICAV in general meeting, in which case the Shareholders at such meeting may appoint Auditors. Where no appointment is made under this Section 38.4, the first Auditors may be appointed by the Shareholders in general meeting.

38.5 Where the Directors have dispensed with the requirement to hold an annual general meeting in accordance with Section 24.3, the Directors shall appoint the Auditors. Where, in any case, no Auditors are appointed as required under this Section 38, the Central Bank may appoint a person to fill the vacancy.

38.6 The remuneration of the Auditors who are appointed by the ICAV in general meeting shall be fixed by the ICAV in general meeting or in such manner as the ICAV in general meeting may determine. The remuneration of the Auditors who are appointed by the Directors or the Central Bank shall be fixed by the Directors or the Central Bank (and will be payable by the ICAV where fixed by the Central Bank).

38.7 The Auditors shall examine such books, accounts and vouchers as may be necessary for the performance of their duties.

38.8 The report of the Auditors to the Shareholders on the audited accounts of the ICAV shall state whether in the Auditors' opinion the balance sheet and profit and loss account in their opinion give a true and fair view of the state of the ICAV's affairs and of its profit and loss for the period in question.

38.9 The Auditors shall have a right of access at all times to the accounting records of the ICAV. The Auditors shall be entitled to require from the Officers such information and explanations as they think necessary for the performance of their duties as Auditors.

- 38.10 The Auditors shall be entitled to attend any general meeting of the ICAV at which any accounts which have been examined or reported on by them are to be laid before the ICAV and to be heard at any general meeting on any part of the business of the meeting which is of concern to them as Auditors and in this regard, make any statement or explanations they may desire with respect to the accounts and notice of every such meeting, and other communications relating thereto, shall be given to the Auditors in the manner prescribed for the Shareholders.
- 38.11 The Auditors shall be eligible for re-election.

39 Notices

- 39.1 Any notice or other document required to be served upon or sent to a Shareholder shall be deemed to have been duly given if sent by post or left at his/her address as appearing on the Register, or sent by fax or by electronic mail to an e-mail address or (save in the case of a notice of a general meeting of the ICAV) if either the full text of the notice or documents is published in a national daily newspaper in Ireland or such other publication as the ICAV may from time to time decide circulating in any country where the Shares are marketed, or an advertisement is so published stating where copies of such notices or documents may be obtained. In the case of joint holders of a Share, all notices shall be given to that one of the joint holders whose name stands first in the Register in respect of the joint holding, and notice so given shall be sufficient notice to all the joint holders. Any notice or other document, served by post, shall be deemed to have been served 24 hours after the time that the letter containing the same is posted and in proving such service, it shall be sufficient to prove that the letter containing the notice or document was properly addressed and duly posted. Any notice or other document, served by delivery, shall be deemed to have been served at the time of delivery and in proving such service, it shall be sufficient to prove that the letter containing the notice or document was properly addressed and duly delivered.
- 39.2 Any notice or document sent by post to or left at the registered address of a Shareholder or sent by fax or by electronic mail to an e-mail address, shall notwithstanding that such Shareholder be then dead or bankrupt and whether or not the ICAV has notice of his/her death or bankruptcy be deemed to have been duly served or sent and such service shall be deemed a sufficient service on receipt by all persons interested (whether jointly with or as claiming through or under him/her) in the Shares concerned.
- 39.3 Any certificate or notice or other document which is sent by post to or left at the registered address of the Shareholder named therein or sent by fax or electronic mail to an e-mail address or dispatched by the ICAV, the Depositary, the Administrator or the AIFM, in accordance with his/her instructions shall be so sent left or dispatched at the risk of such Shareholder.

40 Winding Up

- 40.1 If the ICAV or a Fund shall be wound up or dissolved, the liquidator shall apply the assets of the ICAV or the Fund (as appropriate) in satisfaction of the relevant creditors' claims in such manner and order as the liquidator thinks fit subject to section 154 of the Act.
- 40.2 The assets of the ICAV or the Fund (as appropriate) available for distribution (after satisfaction of the relevant creditors' claims) amongst the relevant Shareholders shall applied in the following priority: (i) first, in the payment to the Shareholders, a sum in the Base

Currency (or in any other currency selected by the liquidator) as nearly as possible equal (at a rate of exchange determined by the liquidator) to the relevant Net Asset Value per Share of the Shares held by the relevant Shareholders as at the date of commencement to wind up provided that there are sufficient assets in the relevant Fund to enable such payment to be made; (ii) secondly, in the payment to the holders of the Subscriber Shares of sums up to the nominal amount paid thereon out of the assets of ICAV; and (iii) thirdly, in the payment to the Shareholders of any balance then remaining, such payment being made in proportion to the number of Shares held.

40.3 If the ICAV or a Fund shall be wound up or dissolved (whether the liquidation is voluntary, under supervision or by the Court) the liquidator may with the authority of a Special Resolution of the ICAV or the Shareholders of the Fund (as appropriate), divide among the relevant Shareholders pro-rata to the value of their Shareholdings in the ICAV or in the relevant Fund (as appropriate and as determined in accordance with Section 21 herein) in specie the whole or any part of the assets of the ICAV or the Fund, and whether or not the assets shall consist of property of a single kind and may for such purposes value any class or classes of property in accordance with the valuation provisions in Section 22. The liquidator may, with the like authority, vest any part of the assets in trustees upon such trusts for the benefit of the relevant Shareholders as the liquidator shall think fit, and the liquidation of the ICAV or the Fund may be closed and the ICAV or the Fund dissolved, but not so that any Shareholder shall be compelled to accept any asset in respect of which there is a liability. If a Shareholder so requests, the AIFM shall sell the assets to be distributed to that Shareholder and distribute the cash proceeds to the Shareholder. The relevant Shareholders will bear any risks of the distributed securities and may be required to pay a brokerage commission or other costs in order to dispose of such securities.

41 Indemnity

41.1 The Directors (including alternate Directors), Secretary and other officers or servants for the time being of the ICAV, for the time being acting in relation to any of the affairs of the ICAV and each of them, and each of their heirs, administrators and executors, shall be indemnified and held harmless out of the assets and profits of the ICAV from and against any and all claim, demand, action, proceeding, liability, damage, loss, charge, detriment, cost or expense (including, without limitation, all reasonable legal fees in relation thereto) suffered, incurred or sustained by them arising directly or indirectly out of or in connection with acting as a Director (including alternate Directors), Secretary and other officer or servant (as the case may be) of the ICAV or otherwise in connection with the performance or non-performance of duties as such otherwise than by reason of their negligence, default, breach of duty or breach of trust. The amount for which such indemnity is provided shall immediately attach as a lien on the property of the ICAV and have priority as between the Shareholders over all other claims. None of the foregoing shall be answerable for the acts, receipts, neglects, defaults or breaches of the other or others of them, or for joining in any receipt for sake of conformity, or for any bankers, brokers, or other person into whose hands any money or assets of the ICAV may come, or for any defects of title of the ICAV to any property purchased, or for insufficiency or deficiency of or defect of title of the ICAV to any security upon which any moneys of or belonging to the ICAV shall be placed out or invested, or for any loss, misfortune or damage resulting from any such cause as aforesaid, or which may happen in the execution of their respective offices or trusts, or in relation thereto, unless the same shall happen by or through their own negligence, default, breach of duty or breach of trust respectively.

- 41.2 None of the Indemnified Persons will have any liability for any claims and expenses of the ICAV, any Fund or any Investor arising in connection with the services to be performed hereunder or pursuant hereto, or under or pursuant to any agreement relating to the ICAV or any Fund or in respect of services as Director, AIFM or Investor Advisory Committee member or which otherwise arises in relation to the operation, business or activities of the ICAV and any of its Funds save (i) in respect of any matter resulting from such Indemnified Person's fraud, wilful misconduct, bad faith or reckless disregard for their obligations and duties in relation to the ICAV, any Fund or the Investors, or in the case of the Directors, their negligence, or in the case of other Indemnified Persons, their gross negligence (provided that such gross negligence has had a material adverse economic effect on the Investors or the ICAV), and (ii) in respect of any claim resulting from legal proceedings between the ICAV, the Directors, the AIFM, or any of their respective shareholders, directors, officers, employees, agents or affiliates on the one hand, and an Investor, on the other hand. For the purposes of this section, "gross negligence" means conduct which exhibits a reckless disregard for the rights of others.
- 41.3 Subject to applicable law, the Depositary, the Administrator, the Distributor, the Investment Manager and any sub-investment manager to the ICAV shall be entitled to such indemnity from the ICAV upon such terms and subject to such conditions and exceptions and with such entitlement to have recourse to the assets of the ICAV with a view to meeting and discharging the cost thereof as shall be provided under their respective agreements with the ICAV or with the AIFM acting on behalf of the ICAV.
- 41.4 The ICAV, the Directors, the Depositary, the Administrator, the Investment Manager and any sub-investment manager to the ICAV shall be entitled to rely absolutely on any declaration received from a Shareholder as to residence or otherwise of such Shareholder and shall not incur any liability in respect of any action taken or thing suffered by any of them in good faith in reliance upon any paper or document believed to be genuine and to have been sealed or signed by the proper parties nor be in any way liable for any forged or unauthorised signature on or any common seal affixed to any such document or for acting on or giving effect to any such forged or unauthorised signature or common seal but shall be entitled though not bound to require the signature of any person to be verified by a banker, broker or other responsible person or otherwise authenticated to its or their satisfaction.
- 41.5 The Distributor shall also have the power to grant indemnities in favour of any such sub-distributors, nominees, agents or delegates out of the assets of the ICAV, in accordance with the terms as may be agreed from time to time between the ICAV and the Distributor.
- 41.6 The ICAV, the Directors, the Depositary, the Administrator, the Investment Manager and any sub-investment manager to the ICAV shall incur no liability to the Shareholders for doing or (as the case may be) failing to do any act or thing which by reason of any provision of any present or future law or regulation made pursuant thereto, or of any decree, order or judgment of any court, or by reason of any request announcement or similar action (whether of binding legal effect or not) which may be taken or made by any person or body acting with or purporting to exercise the authority of any government (whether legally or otherwise) either they or any of them shall be directed or requested to do or perform or to forbear from doing or performing. If for any reason it becomes impossible or impracticable to carry out any of the provisions of this Instrument neither the ICAV nor the Director nor, subject to the terms of the Depositary Agreement, the Administration Agreement, the Investment Management Agreement and any sub-investment management agreement, the Depositary nor the

Administrator nor the Investment Manager nor any sub-investment manager shall be under any liability therefore or thereby.

42 **Destruction of Documents**

42.1 The ICAV may destroy:

42.1.1 any dividend mandate or Share allotment request form or any variation or cancellation thereof or any notification of change of name or address at any time after the expiry of two years from the date such mandate, request, variation, cancellation or notification was recorded by the ICAV;

42.1.2 any instrument of transfer of Shares which has been registered at any time after the expiry of six years from the date of registration thereof; and

42.1.3 any other document on the basis of which an entry in the Register is made at any time after the expiry of ten years from the date an entry in the Register was first made in respect of it;

and it shall conclusively be presumed in favour of the ICAV that every instrument of transfer so destroyed was a valid and effective instrument duly and properly registered and that every other document hereinbefore mentioned so destroyed was a valid and effective document in accordance with the recorded particulars thereof in the books or records of the ICAV **PROVIDED ALWAYS** that:

42.1.4 the foregoing provisions of this Section shall apply only to the destruction of a document in good faith and without express notice to the ICAV that the preservation of such document was relevant to a claim;

42.1.5 nothing contained in this Section shall be construed as imposing upon the ICAV any liability in respect of the destruction of any such document earlier than as aforesaid or in any case where the conditions of proviso (i) above are not fulfilled; and

42.1.6 references in this Section to the destruction of any document includes references to its disposal in any manner.

43 **Severability**

If any term, provision, covenant or restriction of this Instrument is held by a court of competent jurisdiction or other authority to be invalid, void, unenforceable or against its regulatory policy, the remainder of the terms, provisions, covenants and restrictions of this Instrument shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

44 **Modification of this Instrument**

44.1 No modification shall be made to this Instrument without the approval of the Central Bank. Any such modification may only be made in accordance with the requirements of the Act.

44.2 The ICAV, subject to the prior approval of the Central Bank, shall be entitled to modify, alter or add to the provisions of this Instrument, without the prior approval of the Shareholders

where the Depositary certifies that the modification, alteration or addition does not materially prejudice the interests of the Shareholders and is not one which the Central Bank has specified as one requiring approval of the Shareholders.

44.3 The ICAV, subject to the prior approval of the Central Bank, shall be entitled to modify, alter or add to the provisions of this Instrument, with the sanction of an ordinary resolution of a meeting of Shareholders duly convened and held in accordance with the provisions contained in this Instrument, provided that no such modification, alteration or addition shall be made which shall reduce the interest in any Fund of any Shareholder (without similarly reducing the interests of all Shareholders in such Fund) or reduce the percentage of Shares required to consent to any modification, alteration or addition without the consent of all Shareholders.

44.4 Without prejudice to the foregoing, the ICAV shall be entitled (and without the sanction of an ordinary resolution as aforesaid) to modify, alter or add to the provisions of this Instrument in such manner and to such extent as they may consider necessary or expedient having regard to the provisions of any fiscal enactments for the time being in force affecting the ICAV and any arrangements approved by the Revenue Commissioners of Ireland in relation to the carrying into effect hereof or to conform to any legislation, provided that no such modification, alteration or addition shall impose upon any Shareholder any obligation to make any further payment in respect of his Shares or to accept any liability in respect thereof.

Schedule 1 - Qualified Holder Restrictions

- 1.1 Shareholders are required to notify the ICAV immediately in the event that any Status Declaration is no longer valid. In addition, Shareholders are required to notify the ICAV if any information provided or representations made by them in the Subscription Agreement is no longer correct.
- 1.2 Shareholders are required, as requested by the Directors upon an application for Shares or at any other time and from time to time, to furnish such evidence to the Directors in connection with the matters stated in paragraph 1.1 above as the Directors shall in their discretion deem sufficient.
- 1.3 If a person becomes aware that he/she is holding or owning Shares in contravention of this Schedule 1 or the Instrument or in the circumstances set out in Section 15.2, he/she shall forthwith in writing request the ICAV to redeem such Shares in accordance with Section 17 or shall transfer such Shares to a person duly qualified to hold the same unless he/she has already received a notice under paragraph 1.4 below.
- 1.4 Where the Directors, in their absolute discretion, consider that a person is holding Shares in one of the circumstances listed in Section 15.2 above (or where they have reason to believe this to be the case), the ICAV may notify the Shareholder and: (i) direct the Shareholder to dispose of those Shares to a person who is entitled to own the Shares within such time period as the ICAV stipulates; or (ii) redeem the Shares at the Net Asset Value per Share, less any applicable Duties and Charges and any redemption fee as at the next Redemption Day or Dealing Day after the date of notification to the Shareholder or following the end of the period specified for disposal pursuant to (i) above.
- 1.5 If any such person upon whom such a notice is served as aforesaid does not within thirty (30) days after such notice has been served transfer such Shares or request in writing the ICAV to redeem the Shares he/she shall be deemed forthwith upon the expiration of the said thirty (30) days to have so requested the redemption of all his/her Shares the subject of such notice whereupon if he/she shall have been issued with a certificate for his/her Shares he/she shall be bound to deliver the certificate to the ICAV forthwith and the Directors shall be entitled to appoint any person to sign on his/her behalf such documents as may be required for the purpose of the redemption. To any such repurchase the provisions of Section 17 shall apply, subject to paragraph 1.4 above and save that the deemed request to redeem the Shares may not be withdrawn notwithstanding that the determination of the relevant Net Asset Value may have been suspended under Section 21.11.
- 1.6 Subject to Section 17, settlement shall be effected (subject to any requisite official consents first having been obtained) by depositing the redemption monies or proceeds of sale in a bank for payment to the person entitled upon such consents being obtained. Upon deposit of such redemption monies as aforesaid such person shall have no further interest in such Shares or any of them or any claim in respect thereof except the right to claim without recourse to the ICAV the redemption monies so deposited (without interest) upon such consents being obtained.
- 1.7 Any person or persons failing to comply with his or her obligations pursuant to the Instrument, including this Schedule 1, shall indemnify the Directors, the ICAV, the Administrator, the Depositary, the AIFM, the Investment Manager, any entity appointed as investment advisor, the Distributor and the Shareholders (each an "**Indemnified Party**") from any claims, demands, proceedings, liabilities, damages, losses, costs and expenses directly or indirectly suffered or incurred by such Indemnified Party arising out of or in connection with the failure of such person to comply with his or her obligations pursuant to the Instrument or the Prospectus, including this Schedule 1.

Schedule 2 - Valuation of Assets

- (a) The Net Asset Value of the ICAV shall be calculated in accordance with the provisions of this Schedule. All approvals given or decisions made by the Depositary pursuant to this Schedule shall be given or made, as the case may be, following consultation with the AIFM.
- (b) The Net Asset Value of a Fund shall be calculated by ascertaining the value of the assets of the relevant Fund and deducting from such amount the liabilities of the Fund, which shall include all fees and expenses payable and / or accrued and / or estimated to be payable out of the assets of the Fund.
- (c) The Net Asset Value of each Fund and the Net Asset Value per Share in each Fund in respect of any Dealing Day will be calculated using the value of the relevant assets or liabilities as at their respective Valuation Points and will be determined at the time set out in the Prospectus.
- (d) Each asset which is quoted, listed, or traded on or under the rules of any Recognised Market shall be valued at the latest available dealing price as of the close of business on each Recognised Market on each Valuation Day (as defined in the Prospectus), or, in the case of a Valuation Day (as defined in the Prospectus) which is not also a Business Day, at the close of business on the immediately preceding Business Day. If the asset is normally quoted, listed, or traded on or under the rules of more than one Recognised Market, the relevant Recognised Market shall be that which the AIFM determines provides the fairest criterion of value for the asset. If prices for an asset quoted, listed, or traded on the relevant Recognised Market are not available at the relevant time or are unrepresentative in the opinion of the AIFM, such Investment shall be valued at such value as shall be estimated with care and good faith as the probable realisation value of the asset by the AIFM in consultation with the Valuer. Neither the AIFM nor the Valuer shall be liable if a price reasonably believed by them to be the latest available price may be found not to be such.
- (e) The value of any investment which is not normally quoted, listed or traded on or under the rules of a Recognised Market or in respect of which the AIFM determines that the latest dealing price is not representative of its fair market value, shall be valued at its probable realisation value, estimated with care and in good faith by the AIFM in consultation with the Valuer.
- (f) Shares, units or participation interests in collective investment schemes shall be valued on the basis of the latest released net asset value of such shares as reported by or on behalf of each collective investment scheme. If such prices are unavailable the shares will be valued at their probable realisation value estimated with care and good faith by the AIFM in consultation with the Valuer. Neither the AIFM nor the Valuer shall be under any liability if a price reasonably believed by them to be the latest available price may be found not to be such. In the event that the AIFM does not receive a valuation from a collective investment scheme on a timely basis, or determines, in its sole discretion, that a valuation is inaccurate or incomplete, the AIFM or Valuer may, in its sole discretion, determine the fair value of the Fund's interests in the collective investment scheme independently of the collective investment scheme's valuations based on the best available information, which may be the information most recently provided by a collective investment scheme to the AIFM or Valuer, and any factors deemed relevant by the AIFM or Valuer at the time of such valuation. The value of assets that lack a readily ascertainable market value may be subject to later adjustment based on valuation information available at that time including, for example, as

a result of year-end audits. It is not expected that the Fund will make adjustments to correct such determinations to reflect information that becomes available to the Fund at a later date, although the AIFM may make such adjustments in its sole discretion.

- (g) Cash deposits and similar assets shall be valued at their face value together with accrued interest unless, in the opinion of the AIFM, an adjustment should be made to reflect the fair value thereof.
- (h) Derivative instruments which are traded on a Recognised Market shall be valued at the settlement price as determined by the relevant Recognised Market at the close of business on that market on each Valuation Day (as defined in the Prospectus), or in the case of a Valuation Day (as defined in the Prospectus) which is not also a Business Day at the close of business on that market on the immediately preceding Business Day, provided that where it is not the practice of the relevant Recognised Market to quote a settlement price, or if a settlement price is not available for any reason, such instruments shall be valued at their probable realisation value estimated with care and good faith by the AIFM in consultation with the Valuer.
- (i) Derivative instruments which are not dealt on a Recognised Market shall be valued on each Valuation Day (as defined in the Prospectus) at a price obtained from the counterparty or the AIFM (or the Valuer). Notwithstanding the above provisions, forward foreign exchange contracts and interest rate swap contracts may be valued by reference to freely available market quotations.
- (j) Certificates of deposit shall be valued by reference to the latest available offer price for certificates of deposit of like maturity, amount and credit risk at the relevant Valuation Point or, if the offer price is not available, at the latest available bid price, or if the bid price is not available or is unrepresentative of the value of such certificates of deposit in the opinion of the AIFM, at probable realisation value, estimated with care and in good faith by the AIFM in consultation with the Valuer. Treasury bills and bills of exchange shall be valued with reference to the latest available bid prices ruling in the relevant markets for such instruments of like maturity, amount and credit risk at the relevant Valuation Point.
- (k) Notwithstanding the above provisions the AIFM may (a) adjust the valuation of any listed investment; or (b) permit some other method of valuation to be used either for a specific asset or a class of assets generally if, having regard to currency, applicable rate of interest, maturity, marketability and / or such other considerations as they deem relevant, it considers that such adjustment or alternative method of valuation is required to reflect more fairly the value thereof.
- (l) In determining a Fund's Net Asset Value, all assets and liabilities initially expressed in foreign currencies will be converted into the Base Currency using the latest available exchange rates at the Valuation Point. If quotations are not available, the exchange rate will be determined in accordance with policies established in good faith by the AIFM.
- (m) Save where the determination of the Net Asset Value per Share in respect of the ICAV has been temporarily suspended in the circumstances described in Section 21.11, the Net Asset Value per Share of each Fund shall be made public at the registered office of the ICAV, on request from the AIFM and on such media as may be decided from time to time by the Directors or the AIFM on behalf of the ICAV and, if applicable, will be notified to Euronext

Dublin without delay following calculation. Subscription and redemption prices of Shares shall be made available to Shareholders on request to the Administrator.

Schedule 3 - Additional Powers of the ICAV

1. To carry on business as an investment vehicle and for that purpose to acquire, dispose of, invest in and hold by way of investment, either in the name of the ICAV or in that of any nominee, any interest in any real estate (whether leasehold, freehold or otherwise) or real estate related interest and any shares, stocks, warrants, units, participation certificates, debentures, debenture stock, bonds, obligations, collateralised obligations, loans, loan stock, notes, loan notes, promissory notes, structured notes, structured bonds, structured debentures, commercial paper, certificates of deposit, bills of exchange, trade bills, treasury bills, futures contracts, swap contracts, contracts for differences, commodities of every description (including precious metals and oil), variable or floating rate securities, securities in respect of which the return and / or redemption amount is calculated by reference to any index, price or rate, options contracts, forward rate agreements, policies of assurance and insurance, currencies, money market instruments and financial instruments and securities of whatsoever nature created, issued or guaranteed by any company wherever incorporated or carrying on business or by any partnership, trust, unit trust, mutual fund or other collective investment scheme of whatsoever nature wherever formed or registered or carrying on business or issued or guaranteed by any government, government instrumentality, political subdivisions, sovereign ruler, commissioners, public body or authority supreme, dependant, state, territorial, commonwealth, municipal, local, supranational or otherwise in any part of the world, units of or participation in any unit trust scheme, mutual fund or other collective investment scheme in any part of the world and whether or not fully paid up, and any present or future rights and interest to or in any of the foregoing, and from time to time to acquire, invest in, and vary, exchange, grant, sell and dispose of options over any of the foregoing and to subscribe for the same subject to such terms and conditions (if any) as may be thought fit and to exercise and enforce all rights and powers conferred by or incidental to the ownership or holding of any of the foregoing or of any legal or equitable interest therein and to deposit money (or place money on current account) with such persons in such currencies and otherwise on such terms as may seem expedient;
2. To deposit money, securities and any other property of whatsoever nature to or with such person, and on such terms as may seem expedient and to discount, buy and sell bills, notes, warrants, coupons and other negotiable or transferable instruments, securities or documents of whatsoever nature;
3. To do all such other things as may be deemed requisite, incidental or conducive to the attainment of the objects of the ICAV;
4. With the prior approval of the Investor Advisory Committee, to receive money on loan and to borrow or raise money in any currency in any manner and to secure or discharge any debt or obligation of or binding on the ICAV in any manner and in particular, but without limitation, by the issue of debentures and to secure with or without consideration the repayment of any money borrowed, raised or owing by mortgage, charge, debenture, debenture stock, bond, indemnity, lien or security of whatsoever nature against the whole or any part of the ICAV's undertaking, property or assets (whether present or future) and also by a similar mortgage, charge, debenture, debenture stock, bond, indemnity, lien or security of whatsoever nature to secure or guarantee the performance of any obligation or liability undertaken by the ICAV or by any other company or person;
5. To employ derivative instruments and techniques of all kinds for investment purposes and for the efficient management of the ICAV's assets and, in particular, but without prejudice to

the generality of the foregoing, to enter into, accept, issue and otherwise deal with sale and repurchase agreements, futures contracts, options, securities lending agreements, short sales agreements, when-issued, delayed delivery and forward commitment agreements, foreign currency spot and forward rate exchange contracts, forward rate agreements, swaps, collars, floors and caps and other foreign exchange or interest rate hedging and investment arrangements;

6. Where required for the direct pursuit of the business of the ICAV, to acquire by purchase, lease, exchange, hire or otherwise any estate or interest (whether immediate or reversionary and whether vested or contingent) in any lands, tenements or hereditaments of any tenure and wheresoever situate and to hold, manage and deal with the said lands, tenements or hereditaments and to carry out any works thereto and to sell, lease, let, mortgage or otherwise dispose of any estate or interest therein;
7. Where required for the direct pursuit of the business of the ICAV, to acquire by purchase, lease, exchange, hire or otherwise any personal property of whatsoever nature wheresoever situate or any interest therein and to hold, manage and deal with the said property and sell, lease, let, mortgage or otherwise dispose of the said property;
8. To carry on all kinds of financial, trust, agency, broking and other operations including underwriting, issuing on commission or otherwise of stock and securities of all kinds;
9. To accumulate capital for any of the purposes of the ICAV, and to appropriate any of the ICAV's assets to specific purposes, either conditionally or unconditionally and to admit any class or section of those who have any dealings with the ICAV to any share in the profits thereof or to any other special rights, privileges, advantages or benefits;
10. To guarantee the payment of money by or the performance of any contracts, liabilities, obligations, or engagements of any company, firm or person (including, without limitation, any unincorporated association, partnership, limited partnership, trust, unit trust, mutual fund or other collective investment scheme in any part of the world) and to grant guarantees and indemnities of every description, and to undertake obligations of every description;
11. To create, maintain, invest and deal with any reserve or sinking funds for redemption of obligations of the ICAV or for any other purpose of the ICAV;
12. To enter into any arrangements with any government or authority supreme, dependent, municipal, local or otherwise in any part of the world and to obtain from any such government or authority any rights, concessions and privileges that may seem conducive to the objects of the ICAV or any of them;
13. To employ any person for the purposes of the business carried on by the ICAV or to employ or enter into any contract for services with any person, firm, company or other body to investigate and examine the conditions, prospects, values, character and circumstances of any business concern or undertaking and generally of any assets, concessions, properties or rights and to provide administration, custodian, investment management and advisory and distribution services to the ICAV;
14. To take out, acquire, surrender and assign policies of assurance with any insurance company or companies it may think fit payable at fixed or uncertain dates or upon the happening of any contingency whatsoever and to pay the premiums thereon;

15. To promote and aid in promoting, constitute, form or organise companies, syndicates or partnerships of all kinds for the purpose of acquiring and undertaking any property and liabilities of the ICAV;
16. To promote, constitute, form or organise any company or companies, unincorporated associations, syndicates, partnerships, limited partnerships, trusts, unit trusts, mutual funds or collective investment schemes of all kinds in any part of the world and to subscribe for shares or units therein or other securities thereof for the purpose of carrying on any business which the ICAV is authorised to carry on and / or for the purpose of its or their acquiring all or any of the property, rights and liabilities of the ICAV and / or for the purpose of advancing directly or indirectly the objects of the ICAV, and / or for any other purpose which may seem directly or indirectly calculated to benefit the ICAV and to pay any or all of the expenses of or incidental thereto;
17. To amalgamate or enter into partnership or into any arrangement for sharing profits, union of interest, joint venture, reciprocal concessions or co-operation with any person or company carrying on, engaged in, or about to carry on or engage in any business or transaction which the company is authorised to carry on or engage in, or any business or transaction capable of being conducted so as directly or indirectly to benefit the ICAV, and to take or otherwise acquire and hold, sell, re-issue, or otherwise deal with shares or stock in or securities or obligations of, and to subsidise or otherwise assist any such securities or obligations or any dividends upon any such shares or stock;
18. To establish and / or carry on any other business or businesses which may seem to the ICAV capable of being conveniently carried on in connection with any business which the ICAV is authorised to carry on, or may seem to the ICAV calculated directly or indirectly to benefit the ICAV or to enhance the value of or render profitable any of the ICAV's properties or rights;
19. To acquire and carry on all or any part of the business, goodwill or property, and to undertake any liabilities of any person, firm, association, company, unincorporated association, partnership, limited partnership, trust, unit trust or other collective investment scheme possessed of property suitable for any of the purposes of the ICAV, or carrying on or proposing to carry on any business which the ICAV is authorised to carry on, and as the consideration for the same to pay cash or to issue any fully or partly paid up shares, debentures, or obligations of the ICAV or undertake all or any of the liabilities of such person, firm association, company, unincorporated association, partnership, limited partnership, trust, unit trust or other collective investment scheme;
20. To create, issue, make, draw, accept, endorse, discount, negotiate and otherwise deal with redeemable debentures or bonds or other obligations, bills of exchange, promissory notes, letters of credit or other negotiable or mercantile instruments;
21. To the extent provided by law to obtain and hold, either alone or jointly with any person or company in any part of the world, insurance cover in respect of any risk of the ICAV, its directors, officers, employees and agents;
22. To distribute among the members of the ICAV in specie any assets of the ICAV or any proceeds of sale or disposal of any assets of the ICAV and in particular to repay any surplus or premiums on any shares of the ICAV;

23. To sell, let, lend, develop, dispose of or otherwise deal with the undertaking, property or assets of the ICAV or any part thereof or all or any part of the property, rights or privileges of the ICAV upon such terms as the ICAV may think fit, with power to accept as the consideration, any shares, stocks, units, debentures, mortgages, indemnities, liens, pledges, hypothecations, securities or obligations of whatsoever nature of or interest in any other company, unincorporated association, partnership, limited partnership, trust, unit trust or other collective investment scheme or any mortgage, pledge or hypothecation of such interests;
24. To acquire by purchase, exchange, lease, fee farm grant or otherwise, either for an estate in fee simple or for any lesser estate or other estate or interest, whether immediate or reversionary, and whether vested or contingent, any lands, tenements or hereditament of any tenure, whether subject or not to any charges or encumbrances and whether or not such acquisition be by way of investment or otherwise for the direct pursuit of its business;
25. To remunerate any companies, firms or persons for services rendered or to be rendered to the ICAV including in particular, but without limitation, services rendered or to be rendered in placing or assisting to place or guaranteeing the placing of any of the shares in the ICAV's capital or any debentures or other securities of the ICAV or in or about the promotion of the ICAV or the conduct of its business and whether by cash payment or by the allotment to him/her or them of stocks, shares, debentures, bonds or other securities of the ICAV, credited as paid up in full in part or otherwise;
26. To pay out of the funds of the ICAV all expenses of or incidental to or incurred in connection with the formation and incorporation of the ICAV and the promotion of the ICAV and the raising of money for the Company and the issue of its capital or any class thereof, including brokerage and commissions for obtaining applications for or taking, placing or procuring the underwriting of shares, stocks, debentures, bonds or other securities of the ICAV and any other expenses which the Directors shall consider to be in the nature of preliminary expenses;
27. To pay for any property or rights acquired by the ICAV either in cash or by the issue of fully or partly paid shares of the ICAV;
28. To procure the ICAV to be registered or recognised in any part of the world;
29. To do all such other things as may be deemed requisite, incidental or conducive to the attainment of the objects of the ICAV; and
30. To exercise all or any of the powers aforesaid and to do all such other things in any part of the world, whether as principals, agents, contractors, trustees or otherwise, and either by or through trustees, agents, sub-contractors or otherwise and either alone or in partnership or conjunction with any person, ICAV or company, and to contract for the carrying on of any operation connected with the ICAV's business by any person, ICAV or company.
